Sir,

I AS Biswasup Roy and along with force are C/863 Rupchand Poursa and C/1193 Manoranjan Bhuijn while my night patrolling duty that today on 28/09/18 at 22:35 hrs. received a credible source information that a Truck bearing registration No- JH10AQ-1234 is coming from Raghunathpur side via Raghunathpur-Saikora road (SH-8) loaded with coal which has been procured by means of theft or any fraudulent means by Kaimuddin Hazari, s/o Kamal Hazari Vill+PO- Pearbera, PS-Sonamukhi, Dist-Bankura. Accordingly, I along with force (C/863 Rupchand Poursa and C/1193 Manoranjan Bhuijn) left to work out the said source information. After obtaining kind permission from O/C Santuri PS. On way I have tried to collect local witnesses from the nearby villages but none turn up. At Behagoria Mohr I along with force placed a Naka to apprehend that vehicle. At about 23:45 hrs we found that the above noted vehicle is coming from Raghunathpur side. Seeing Police party at Behagoria Mohr the driver of the said vehicle attempted to flee away but on being chased the driver stopped the vehicle on road and fled away the driver in the dark side. After searching it could be ascertained that the said vehicle bearing registration No- JH10AQ-1234 (12 Wheeler) is loaded with coal (Fully covered by tarpolin) approx 15 (fifteen) Ton. I think that this Kaimuddin Hazari, S/O- Kamal Hazari Vill+PO- Pearbera, PS-Sonamukhi, Dist-Bankura, Owner of said vehicle (JH10AQ-1234), driver of the truck (JH10AQ-1234) and others, collected the said coal either theft or by any illegal means and transporting to run a clandestine business. In order to stop this business, Under proper seizure list I seized the Truck having its registration No- JH10AQ-1234 loaded with coal approx 15 (fifteen) Ton, Then I, sealed & labeled approx 01 (One) KG coal as sample coal. After that, I brought that seized vehicle loaded with coal at Santuri PS compound.

I therefore pray before you to lodge a specific case against accused namely Kaimuddin Hazari, s/o Kamal Hazari Vill+PO- Pearbera, PS-Sonamukhi, Dist-Bankura, Registered owner of the seized truck having its bearing No- JH10AQ-1234, Driver of the seized truck bearing No- JH10AQ-1234 and others under proper section of law.
