In producing here with me arrested accd. namely Nilu Mukhi (49 Yrs.) S/O Lt. Kanai Mukhi of Sevanagar, Adra PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 25 bottles (in sealed condition) DIL SE 80 up country spirit, 600-ml each bottle and value-Rs-35 of each bottle.
- 2) Sale proceed of Rs- 205/-
- 3) Ten pieces of plastic glass.

I ASI Habibur Rahman Mondal Adra P.S. do here by lodged a complaint against accd. namely Nilu Mukhi (49 Yrs.) S/O Lt. Kanai Mukhi of Sevanagar, Adra PS- Adra Dist- Purulia to the effect that on 05.10.18 at about 17:15 hrs in course of my Anti crime mobile duty I received a telephonic information from a reliable source that one Nilu Mukhi (49 Yrs.) S/O Lt. Kanai Mukhi of Sevanagar, Adra PS- Adra Dist- Purulia was stocked country spirit. Illegally and selling the same to hilee price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with IC-411 Piuksa Saha & IC-1175 Ratna Kama Saha rushed to the spot for raid by Govt. vehicle. At about 17:35 hrs. myself along with force reached at Sevanagar and hold raid in the [hopri (At Sevanagar)] of Nilu Mukhi found that said Nilu Mukhi selling liquor at his own [hopri and seeing the Police Party some person fled away and said Nilu Mukhi to concealed himself. but we are able to apprehend him and also detained him. I asked him to produced valid license or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing/selling the same. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd. person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accd. Nilu Mukhi (49 Yrs.) S/O Lt. Kanai Mukhi of Sevanagar, Adra PS- Adra Dist- Purulia and arrange for its investigation.
