Fasad HUSEN of village Kamalasthan P.O. Adra P.S. Adra Dist PURULIA has committed theft of Electricity U/S-135 of the Electricity (Amendment) Act 2007.

Entered the premises of TAMIJUR RAHMAN so Lt Fasad HUSEN, village Kamalasthan P.O. Adra P.S. PURULIA Dist Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by bypassing from the incoming service cable before energy meter.

Supply i.e. U/S 135 was detected

From the above system he/she was using the following Electrical equipments i.e.

- 1) cooler - 400 watt - 2 NO'S
- 2) Fridge - 200 watt - 1 NO
- 3) Fan - 3 NO'S - 60 watt
- 4) Bulb - 100 watt - 4 NO'S

Out of which we seized the following:

Bypassing arrangement with service cable approx 1.5 meter

The seizure list is prepared at the site and the accused person signed in the seizure list

The inspection team left the above premises at about 12:30 PM on dated 06/10/2018 The accused person has committed an offence U/S-135(i)(b) of the Electricity (Amendment) Act 2007.
