I Shri Tapas Kumar Ghosh, Inspector of Police, DEB Purulia producing here with arrested accused (1) Kartick Kumar Shaw (30 Yrs) , S/O Debendra Prasad Shaw of Kamalashthan, PS - Adra, (2) Babu Bouri (19 Yrs.) , S/O Buchan Bouri of Joychandi PS - Adra (3) Sumanta Tantubai (34 Yrs.), S/O Durgadas Tantubai of Barabagan, PS - Adra all of district Purulia along with following seized articles (1) 50 Kgs. colour mixed multitude (patal) (2) 10 Ltrs. colour water in a plastic jerrican (3) 01 bamboo made bucket (4) 01 plastic container containing 50 ml. liquid colour (5) 01 plastic packet containing 450 gms. colour mixed multitude (patal) (6) 55 Kgs. colour mixed multitude (patal) (7) 12 Ltrs. colour water in a plastic jerrican (8) 01 bamboo made bucket (9) 01 small plastic container containing 20 grams of dust colour (10) 01 plastic packet containing 450 gms. colour mixed multitude (patal) do here by lodge written complaint to the effect that today (on 09.10.2018) on the basis of secret and credible source information my self along with others Officers and forces of DEB Purulia (1) ASI 849 Swapan Chakraborty (2) C/88 Pradyut Mandal (3) HG 1427 Benimadhan Char came to this PS and noted the secret information at 06.55 hrs in GD vide Adra PS GDE No 339 dated 09.10.2018. There after I along with officers and forces of DEB Purulia and Adra PS had been to Adra Railway Daily Market to work out the information. On arrival at Adra Railway Daily Market we wait there for an hour till the Market started functioning. After some time we observed that in the vegetable selling stall of Kartick Kumar Shaw S/O Debendra Prasad Shaw, he along with one other person engaged in mixing chemical colour to multitude (Patal) for bringing extra shining and glittering of it, there by contaminated such vegetable consumption of which will be injurious to human health and also it appears to be they were administering substance noxious to public health. We placed guard at that vegetable stall and in presence of independent witness Shyam Dev Shaw search the stall and seized the following articles under proper seizure list from 09.05 hrs. (1) 50 Kgs. colour mixed multitude (patal) (2) 10 Ltrs. colour water in a plastic jerrican (3) 01 bamboo made bucket (4) 01 plastic container containing 50 ml. liquid colour (5) 01 plastic packet containing 450 gms. colour mixed multitude (patal) drawn a sample from SI No 1.



We apprehend Kartick Kumar Shaw S/O Debendra Prasad Shaw of Panchudanga, PS - Adra, District - Purulia and his companion who furnished his identity as Babu Bauri S/O Buchan Bauri of Joychandi, PS - Adra, District - Purulia as they fail to produce any satisfactory account for their such activity. Nextly we notice in another vegetable stall of same market near the stall of Kartick Kumar Shaw, owned by Md. Kalam, S/O Md. Aslam of Upper Beniasol, PS - Adra another one person engaged in similar work i.e. mixing chemical colour to vegetable multitude (patal) to bring artificial shining and glittering in it. We round up him on being asked he furnish his identity Sumanta Tantubi, S/O Durga Das Tantubai of Barabagan, PS - Adra, District - Purulia. We pick up two independent witnesses namely (1) Tapas Gorai, S/O Lt. Dukshit Gorai of Giara, PS - Adra, Dist - Purulia. (2) Kamal Gorai, S/O Sadhan Gorai of Giara, PS - Adra, Dist - Purulia. We search the stall and seized the following articles under proper seizure list in presence of witness (1) 55 Kgs. colour mixed multitude (patal) (2) 12 Ltrs. colour water in a plastic jerrican (3) 01 bamboo made bucket (4) 01 small plastic container containing 20 grams of dust colour (5) 01 plastic packet containing 450 gms. colour mixed multitude (patal) drawn a sample from Sl No 1. The substance seized from the spot in Sl No 4 is different in nature from the vegetable (patal) and suspected to be noxious to public health. As the above persons fail to produce any satisfactory account for his such activity I arrest him.

As such for the above activities of the arrested accused persons a case under section 272/120B IPC read with section 7 and 16 of prevention of food adulteration act 1954 may kindly be started against arrested accused 1) Kartick Kumar Shaw (30 Yrs), S/O Debendra Prasad Shaw of Kamalashthan, PS - Adra, (2) Babu Bauri (19 Yrs.), S/O Buchan Bauri of Joychandi PS - Adra (3) Sumanta Tantubai (34 Yrs.), S/O Durgadas Tantubai of Barabagan, PS - Adra all of district Purulia
