In producing here with one arrested a/cd. namely Ranjit Kumar Ram @ Sharukh (28 Yrs) S/O Lt. Inwar Ram of Sevnanagar, Adra PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 17 bottles (in sealed condition) DIL. SE 80 up country spirit, 600-ml each bottle and value-Rs. 35 of each bottle.
- 2) Sale proceed of Rs.- 115/-
- 3) Eight pieces of plastic glass.


I ASI Giridhari Roy Adra P.S. do here by lodged a complaint against a/cd. namely Ranjit Kumar Ram @ Sharukh (28 Yrs) S/O Lt. Inwar Ram of Sevnanagar, Adra PS- Adra Dist- Purulia to the effect that on 12.10.18 at about 14:25 hrs in course of my Anti crime mobile duty I received a telephonic information from a reliable source that one Ranjit Kumar Ram @ Sharukh (28 Yrs) S/O Lt. Inwar Ram of Sevnanagar, Adra PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with C/200 Dasharat Mahato & C/201 Rabindranath Nag rushed to the spot for raid by Govt. vehicle. At about 15:05 hrs. myself along with force reached at Sevnanagar and hold raid in the Ganesty (At Sevnanagar) of Ranjit Kumar Ram @ Sharukh found that said Ranjit Kumar Ram @ Sharukh selling liquor at his own Ganesty and seeing the Police Party some person fled away and said Ranjit Kumar Ram @ Sharukh to conceal himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by a/cd. person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested a/cd. Ranjit Kumar Ram @ Sharukh (28 Yrs) S/O Lt. Inwar Ram of Sevnanagar, Adra PS- Adra Dist- Purulia and arrange for its investigation.
