In producing here with one arrested accd. namely Ranjit Kumar Ram @ Sharukh (28 Yrs) S/O Lt. Iswar Ram of Sevanagar, Adra PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 17 bottles (in sealed condition) DIL SE 80 up country spirit 600-ml each bottle and value-Rs-35 of each bottle.
- 2) Sale proceed of Rs.- 115/-
- 3) Eight pieces of plastic glass.

I ASI Giridhari Roy Adra P.S. do here by lodged a complaint against accd. namely Ranjit Kumar Ram @ Sharukh (28 Yrs) S/O Lt. Iswar Ram of Sevanagar, Adra PS- Adra Dist- Purulia to the effect that on 12.10.18 at about 14:25 hrs in course of my Anti crime mobile duty I received a telephonic information from a reliable source that one Ranjit Kumar Ram @ Sharukh (28 Yrs) S/O Lt. Iswar Ram of Sevanagar, Adra PS- Adra Dist- Purulia was stocking country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with C/200 Dusharat Mahato & C/201 Rabindranath Nag rushed to the spot for raid by Govt. vehicle. At about 15:05 hrs. myself along with force reached at Sevanagar and hold raid in the Gourity (At Sevanagar) of Ranjit Kumar Ram @ Sharukh found that said Ranjit Kumar Ram @ Sharukh selling liquor at his own Gourity and seeing the Police Party some person fled away and said Ranjit Kumar Ram @ Sharukh to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd. person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accd. Ranjit Kumar Ram @ Sharukh (28 Yrs) S/O Lt. Iswar Ram of Sevanagar, Adra PS- Adra Dist- Purulia and arrange for its investigation.
