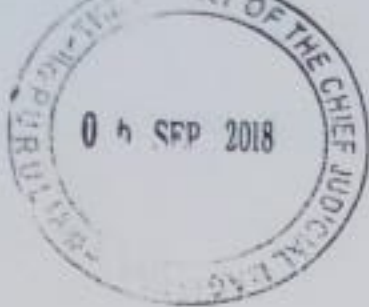

Most Respectfully Sheweth : -

- 1) _____ That the complainant's Paternal home is situated at Vill.-Rasuldih within P.S. Balarampur, Dist.- Purulia, her marriage was solemnized on 30.4.2014. with Tajim Kazi, S/o Meyalal Kazi, of Vill.- Bhursa, P.O. Beldih, P.S.- Arsha, Dist.- Purulia, as ~~per~~ per Muslim rights and customs prevailant in their Community at the father's house of the complainant.
- 2) _____ That ^{at} the time of marriage the father of the complainant had to give cash dowry ~~Rs.~~ Rs.48,000/- (Rupees forty eight thousands) and other valuable articles to the Complainant as per demand of the accused persons.
- 3) _____ That after marriage the accused No.1 the husband of the complainant had taken to her marti-
-monial house at Village- Bhursa, within P.S.-Arsha and reside their as husband and wife , All the accused persons used to reside in a joint mess.
- 4) _____ That after covering some days the complainant was pressurised to bring more money from the father's house as the dowry which was given at the time of marriage was grossly inadequate , and whenever the complainant expressed her inabilities to fulfil

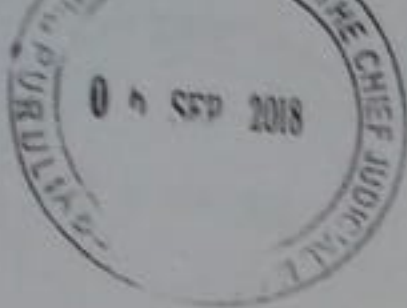

the same and for which she was subjected to physical and mental torture including physical assault by all the accused persons upon the complainant, As a matter of fact in order to maintain a good and cordial relationship the father of the complainant gave Rs.5,000/- (Rupees Five thousand) to the accused persons by selling his goat in order to met-up the further demand of dowry.

5) _____ That thereafter the accused persons being not satisfied again pressurised her to bring more Rs.10,000/- (Rupees Ten thousand) from the complainant from her father's house and when the complainant expressed her inability to fulfil the same and disclosed that as her father is a poorman and her father failed to collect and fulfil the said demand and only on that score she was mercilessly assaulted by her husband and in-laws and ultimately the climax has reached such a stage the complainant was ~~driven~~ driven out from her matrimonial house and out of fear the complainant had to take shelter at her father's house and thereafter she brought the matter at Arsha P.S. and at their intervention the matter was amicably settled between the parties, the complainant again went to her matrimonial house and again resume her conjugal life.

6) _____ That the complainant again with full hope and expectation had started her conjugal life but

again the degree of torture has increased day by day and ultimately the complainant was driven by all the accused persons on 6.8.2018 and the complainant had submitted a written complaint on 7.8.18 but the Officer-in-Charge of that P. S. refused to accept the same without any cogent reason and the same was sent through register Post on 10.8.2018.

7) _____ That thereafter the complainant has submitted a complaint to the Superintendent of Police, Purulia on 17.8.2018 regarding non action on the part of the O/c, Arsha P.S. but curiously no specific case has yet been started against the accused person. As such the complainant by filling this complaint has prayed for sending the said complaint to the Arsha P. S. for causing investigation as contemplated U/s- 156(3) Cr. P. Code.

8) _____ That the Complainant is a poor woman having no source of Income to engage any Private Lawyer for conducting the case. Besides this through investigation is essential.
