Sir,

In producing here with one arrested accd namely Asiwini Sahis (35) S/O Lt. Laxman sahis of vill Tumba Jhalda P.S.-Arsha Dist-Purulia along with following seized articles viz –

- 1) one white colour plastic container with approx 10 ltrs of cholai,
- 2) one white colour plastic container with approx 5 ltrs of cholai,
(Approx 500 ml taken out from the above containers as sample packed with sealing wax)
- 3) 12 bottle (in sealed condition) Dil Se country spirit, 600-ml each bottle and Rs-35 of each bottle .
(One bottle taken out of the above as sample packed, labeled and sealed with sealing wax.
- 4). 10 empty bottle of do in one plastic bag

I, SI Hari Charan Ghosh of Arsha PS do hereby lodged a written complaint against the above noted accused person to the effect that today 10.10.18 at about 18:15 during my evening mobile duty receive source information over telephone that the above noted accused has been selling liquor illegally and clandestinely in front of his house at Tumba Jhalda village under Arsha PS, Dist- Purulia .On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with ASI Joydev Atta, C/-243 Amit Das and C/-644 Ayan Kr. Mandal both of SAP 7th Bn camp at Arsha PS rushed to the spot to work out the information. Reaching at Tumba Jhalda village we fixed-up the house of above noted accd. person and noticed that the seliing country spirit was going on there and getting seen of police all customers were managed to escape, but we able to apprehended the above noted accused person. On demand of papers he failed to produce any valid documents in support of selling country spirit. So I seized all the implicating articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labelled duly signed by the accused persons and witnesses among which one bottle of country spirit was kept as sample file with label. During interrogation he confessed his guilty so, I arrested him after observing all the formalities issuing memo of arrest as the accused persons are liable for prosecution u/s 46A(c) of The Bengal Excise Act,1909.

I therefore pray that a specific case may kindly be started against the accused namely Asiwini Sahis (35) S/O Lt. Laxman sahis of vill Tumba Jhalda P.S.-Arsha Dist-Purulia U/S 46A(c) The Bengal Excise Act,1909, and arrange it's regular investigation.
