I Sri - Narayan Sing Sardar Son of Late Makam Sing Sardar a permanent resident of Vill-Kanda P.O-Dhanudih P.S- Baghmundi Dist- Purulia (W.B) and working in Railway Higher Secondary School/Lumding /N.F.Railway (Assam) like to inform you the following for necessary action from your end please .

That sir, from dated 30/09/2018 to till date i.e .on 02/10/2018 during period from 8 A.M to 6 P.M. and today i.e. 02/10/2018 the accused are still loading and robbing my bricks by 3 tractors bearing no. WB-55 A-2159 . Red by color , WB-55 A-6471 and another one .

That sir, the following persons have forcibly robbed my 50000(Fifty thousand) approx . Bricks bearing name "A.S" from my permanent address by threatening my caretaker Sri - Kartik Mura Son of Sri - Brindaban Mura . and Sri - Chanu Sing Sardar son of Sri - Chaitan Sing Sardar of Vill- Kanrda P.O.- Dhanudih P.S. - Baghmundi Dist- Purulia (W.B) and the Bricks have been transported to the residence of accused no. 1 and 2 in Vill- Kudna P.O- Ekra P.S- Baghmundi Dist- Purulia (W.B) by 3 tractors.

That Sir , The accused are 1) Sri Ganesh mura son of Sri - Brindaban Mura 2) Sarita Mura Daughter of Sri - Brindaban Mura all are residents of Vill- Kudna P.O- Ekra P.S- Baghmundi Dist- Purulia (W.B)

3) Paran Sing Sardar son of Late Makam Sing Sardar of vill- Kanrda P.O- Dhanudih P.S- Baghmundi Dist- Purulia (W.B) and 4) Sri Khudu karmakar son of Late - Benu Karmakar of Vill+P.O- Dhanudih P.S- baghmundi Dist- Purulia (W.B).

That Sir , my caretaker Sri Kartik Mura's lives are at danger please save us and my property . This is my apprehension that above accused will murder us. I pray your help so that I can enter my house without any sad incident created by the accused .

In view of the above you are requested to Lodge an F.I.R against the above mentioned four persons and oblige otherwise I will be in great financial lose of Rs. 600000(Six Lakh) which I have borrowed from state Bank of India , Lumding as personal loan .
