Facts of the case

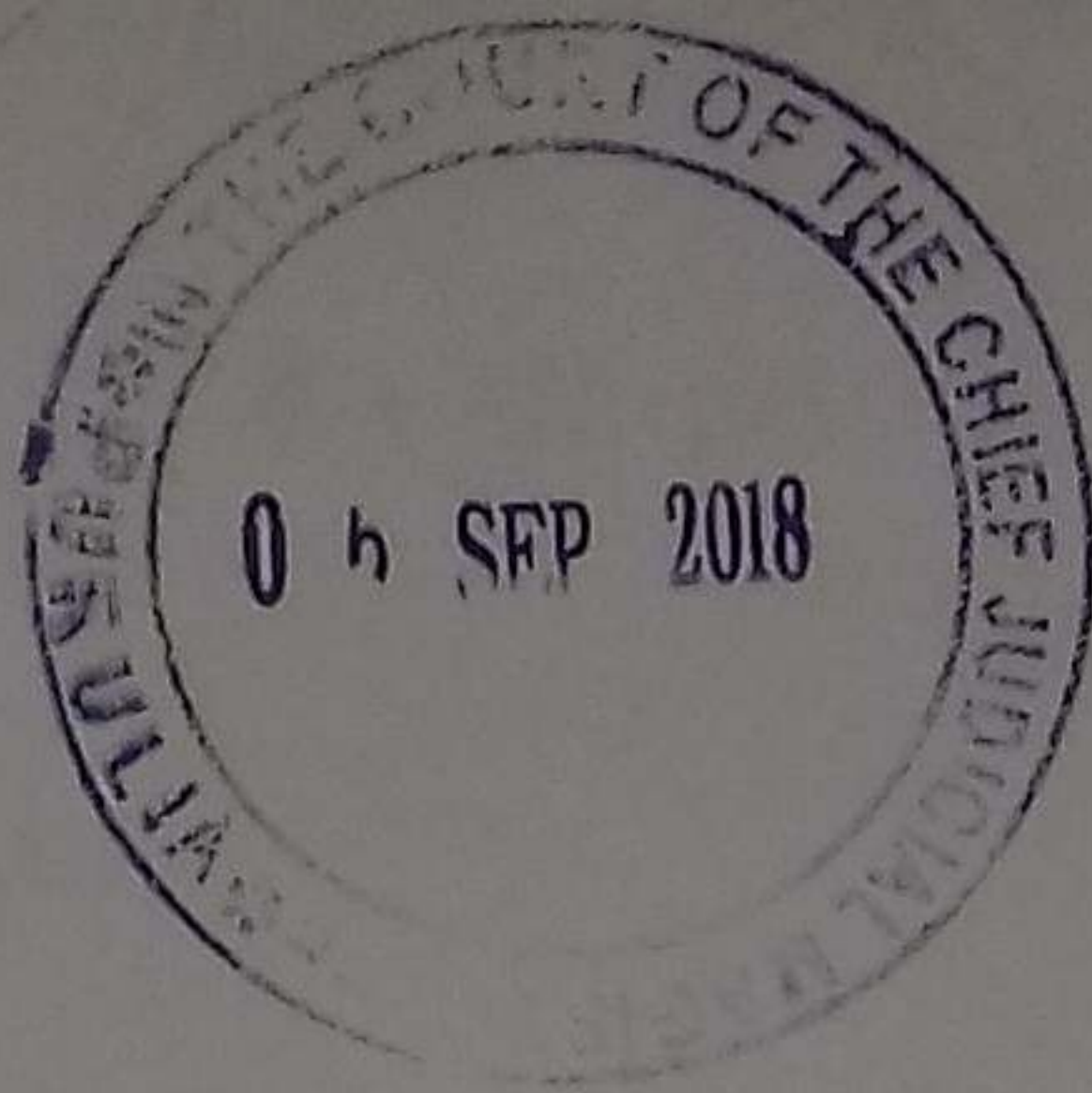
The above named complainant

2. That it may be stated here all the purchasers are closely related to each other and they are in possession over their purchased land mentioned in scheduled below from the date of their respective purchased date.

3. That on 06.08.2017 while the complainant and other purchasers <sup>came to know</sup> that the accused are erecting bamboo poles subsequently they have placed Tin over the roof within their purchased land immediately the complainant and few others rushed to the purchased land and registered them and the complainant and other purchasers told them that they have purchased the scheduled land from their father Kalu Machhuar in four deeds and why they were erecting bamboo poles within their purchased land.

4. That the accused Nos. 2 to 5 disclosed that they will not allow the complainant and other to possess the disputed land and there was hot talk in between the accused Nos. 2 to 5.

That subsequently the complainant and other purchasers received the summonses from the Civil & Court about filing of Title suit No. 1 of 2018 from which the complainant and other purchasers came to know that Kalu Machhuar allegedly has gifted the land of scheduled below in the year 2016 vide deed No. 1886.

6. That the complainant protested that Kalu Machhuar have himself sold out the lands of Scheduled below and how he can gifted the property in the year 2015. (2016)

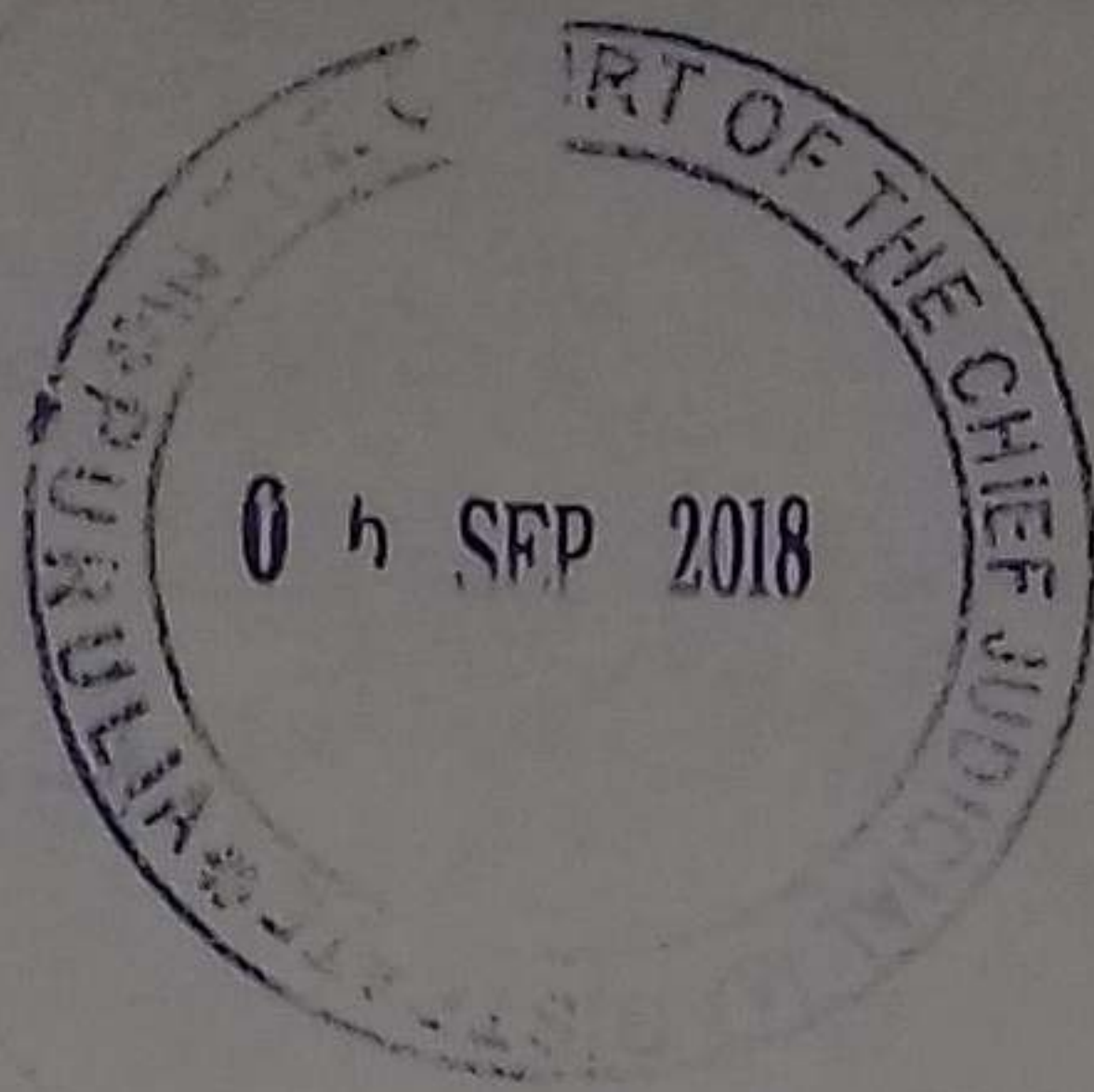

Baghmundi.
