On 26/10/18 at about 03.10 PM I Sri Swapan Kumar Das, AE & Station Manager, Baghmundi CCC along with 1. Sri Ramendra Narayan Sinha, S.O IPRL RM Office, 2. Sri Sukhamoy Maji SAE(E) 3. Sri Shankar Ch. Mahato LM (PRL Rm offin) entered the premises of Sri Nibaran Kumar, S/O- lt Lalu Kumar of village-Kanudi, P.O-Uttamdi P.G-Bagmundi, Dist- Purulia and found Sri Nibaran Kumar was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.100 KVA. As Sri Nibaran Kumar S/O- lt Lalu Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Ramendra Narayan Sinha (S.O) 2. Sri Sukhamoy Maji SAE. The inspection team left the premises at 03.20 PM.
