I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Dayal Kumar S/O- Sri Ramlal Kumar of villege Karvu, ~~P.O~~ P.S- Bagmundi, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 26/10/18 at about 03.50 I Sri Swapan Kumar Das, AE & Station Manager, Baghmundih CCC along with 1. Sri Ramendra Narayan Sinha SO, PRL. RM Office, 2. Sri Sukharnoy Maji SAE (E) 3. Sri Shankar ch. Mahato. LM. entered the premises of Sri Dayal Kumar S/O- Sri Ramlal Kumar of villege Karvu P.S- Bagmundi, Dist- Purulia and found Sri Dayal Kumar was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.100 KVA. As Sri Dayal Kumar S/O- Sri Ramlal Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sukharnoy Maji SAE (E) 2. Sri Shankar Ch. Mahato PRL. Office. The inspection team left the premises at 04.00 PM.
