I do hereby lodged complaints empowered by enabling the Electricity Act, 2003, subsequently Electricity (Amendment) Act, 2007 to effect that **Kanchan Pandey, C/o - Dilip Kumar Pandey** resides at Kuchia, PS - Bundwan, Dist - Purulia, was enjoying Electricity unauthorisely by drawal illegal hooking from the nearest LTOH line of WBSEDCL, on 05/10/2018 at about 04:00 p.m. I Ramesh Singh, SM, Bundwan CCC, WBSEDCL along with Maruli Mahata, Sr. S.A.E, Yeasin Mondal, LM, Debasish Goswami, Sr. T.S.H. visited the premises of **Kanchan Pandey**. During inspection Theft of Electricity was detected. For further enquiry undersigned tried to entered the premises of Kanchan Pandey but he didn't allowed us to entered the premises and **prevented us from discharging our duties and uses slangs**. Also he tried to de hook the hooking device from his terrace. Since he didn't allow us to enter his premises no hooking devices or appliances could not be seved. The accused person has **committed an offence U/S 135/1/A** of the Electricity Act, 2003 and subsequently Electricity (Amendment) Act, 2007.

Hence you are requested to kindly take cognizance of this complaint and treat this as an FIR.
