Fact of the case in brief:-

The Complainant

Most respectfully beg to state as follows:-

1. That on 16/08/2018, the daughter of the complainant's brother-in-law namely Suman Bauri @ Sumita Bauri D/O Goutam Bauri who used to reside under the care and custody of the complainant and used to carry out her studies at Barabazar Girl's High School at Barabazar in class -IX of the said school in residing in his house at Barabazar Namopara and said Suman Bauri like other school days on said 16/08/18 went to the school at about 10.30 A.M on that day but she did not return back to the house since then although the classes had been disbanded at 1 p.m on that day.





2. That the complainant and his family members after search came to know that Suman has been abducted and kidnapped by one Rahul Bouri S/O Krishna Bouri of Road no 4 Adityapur, Jamshedpur and she had been kept in confinement at a secret place at Jamshedpur with bad intention to commit rape upon the minor girl Suman Bauri under the shadow of fake marriage, She is aged about 13 ½ years.

That the complainant and the father of the abducted and kidnapped minor girl, tried to contact with the accused person and his family members but the accused person switched of his phone being Mobile no 7070372881. and is not responding.

That the complainant and the family members of said abducted minor girl are passing their days in great tension and are apprehending that an untoward incident may happen with their minor gir/ Suman @ Sumita Bauri as the where about of the said girl is not known yet to the complainant and the family members.
- 6. That the complainant informed the incident before the Police Barabazar P.S. on the same day verbally and later on by writing but the police did not take appropriate steps against the accused person and the complainant had to inform the matter to the S.P. Purulia on 4/09/18 but of no result, hence the complainant have been compelled to file this application before this Ld. court.
