I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act-2007 , to the effect that Shri BANAMALI SINGH SARDAR, S/O- LT. MONU SINGH SARDAR, VILL-HUCHUKDIH, P.S- BARABAZAR, DIST- PURULIA was enjoying electricity unauthorizedly by direct hooking from nearest LT OH line through single Core PVC cable and he has committed theft of electricity U/S 135(1)/a of the electricity (Amendment act-2007).

On 29.10.2018 I, Sri ANSHUMAN MITRA, A.E & S.M., BARABAZAR CCC along with

- (1) JALAD BARAN GHOSAL, L.M., Barabazar CCC, WBSEDCL
- (2) MD QASIM ANSARI, O.E, Barabazar CCC, WBSEDCL

Entered into the premises of BANAMALI SINGH SARDAR, S/O- LT. MONU SINGH SARDAR, VILL-HUCHUKDIH, P.S- BARABAZAR, DIST- PURULIA and inspected his premises at 07:10 p.m.

During inspection, it was found that BANAMALI SINGH SARDAR, S/O- LT. MONU SINGH SARDAR, VILL-HUCHUKDIH, P.S- BARABAZAR, DIST- PURULIA was enjoying electricity illegally by direct hooking from nearest LT OH line through single Core PVC cable in his premises at HUCHUKDIH with connected load of 0.117 KVA.

From the above arrangement he was using the following equipment:

01. 01 no Electric Bulb (100 watt)

Out of which I seized the following articles:

1. 1 no of single core PVC Cable (8*2 mtr. Approx) with hooking device.

Seizure list was prepared at site and accused person refused to sign. After process of inspection and seizure list we left the premises at about 07:25p.m.

The said person has committed an offence U/S 135(1)/a of electricity act 2003 subsequently electricity (Amendment) act-2007.
