
The above named complainant most respectfully begs to state as follows;

- 1. That the accused Bipadataran Paramanik is a Para Teacher of Manguria Sri Sri Brhamajynma H. S. School and he is known to the Complainant and witness Nos. 2 and 3 since long.
- 2. That the Complainant and the witness Nos. 2 and 3 are unemployed youth and they were in searching jobs for their livelihood and at that motion they came into contact with the accused persons.
- 3. That with an assurance to provide employment in Unemployment Youth.

  Development Organisation, the accused person namely Bipadtaran Paramanik took a sum of Rs. 20, 000/- from the complainant and also from the witness Nos. 2 and 3. Subsequently it came to learn that the witness No. 4 also gave an amount of Rs. 20, 000/- to the Accused No. 1 Bipadtaran Paramanik with an aim to get employment from him.
- 4. That complainant and the witness Nos. 2 and 3 lost their golden time with the hope of a good employment through the Accused Person.
- That the Accused Bipadtaran Faramanik supplied some fake documents in the name of Unemployed Youth Development Organisation regarding employment of the complainant and to the witness Nos. 2, 3 and 4 but actually there was no Organisation in that name.

- 6. That the accused person namely Bipadtaran Paramanik failed to provide any employment to the Complainant and or the witness Nos/2, 3 and 4 but he assured that he will refund the money of the complainant and others.
- 7. That the accused Bipadtaran Paramanik execute a document on his own hand and also put his signature on the same on 29. 03. 2017 agreeing to refund the money of Rs. 80, 000/- to the complainant and also to the witness Nos. 2, 3 and 4 but till date no money has been returned to the complainant and or to the witnesses.
- 8. That the complainant and the witnesses asked several times for returning he money taken by the accused Bipadtaran Paramanik but he avoid the matter.
  - That as per assurance of the accused Bipadtaran Paramanik, on 26. 06. 2018 at about 9 a. m the complai and and witness Nos. 2 and 3 had been to the house of Bipadtaran Paramanik but the accused Bipadtaran Paramanik has not returned the money to the complainant and witnesses rather both the accused uttered filthy languages and assaulted the complainant and the witness Nos. 2 and 3 by fist and blow. Both the accused abused the complainant and the witness Nos. 2 and 3 with filthy languages and also abusing to the caste of the complainant and the witness Nos. 2 and 3 by saying that they are the men of lower caste, they have no respect in the society and they are like street dogs and also said that previously the heirs of Complainant and witness Nos. 2 and 3 used to work in the field of the accused persons like donkey etc. and very bad!y humiliated by insulting the caste of the complainant and the witness Nos. 2 and 3.
- 10. That so many people of the case village were assembled during the aforesaid incident who have knowledge about the incident but the complainant failed to collect their names.
