Sub: - Complaint against Shahar Gope (35) S/o Hazari Gope of Vill- Madhuban, PS Hura, Dist. Purulia to start a cog case U/S-46A(c) B.E. Act.

Sir,

In producing here with arrested accused namely Shahar Gope (35) S/o Hazari Gope of Vill- Madhuban, PS Hura, Dist. Purulia along with seized Country Spirit bottles DILKHUSH & DIL SE (details of seized articles are mentioned in attached seizure list), I beg to submit that today on 08.10.18 at 17.55 hrs received a credible source information and according to that information I, SI Biswajit Sarkar along with force held raid (18.35 hrs.- 19.15 hrs) in the house of above noted accused person at Madhuban village under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling country spirit which was kept in his house. On demand, he failed to produce any valid documents/ License in respect of selling and stocking Country Spirit. Accordingly, I seized all the sealed Country Spirit bottles (details in attached seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample one bottle. Then I, arrested him after preparing proper arrest memo, maintained all formalities regarding arrest as he committed offence U/S 46A(C) B.E. Act and supplied one copy to him. This is to note here that on seeing police party all public/customers fled away. Total 30 (Thirty) bottles country spirit 18 bottles (DILKHUSH) measuring 600 ML each bottle value Rs- 35/- each and 12 bottles (DIL SE) measuring 375 ML each bottles have been seized value Rs. 22 each. Total Value Rs- 894/-

Under the above circumstances and fact, I therefore pray that a Cog. Case U/S 46A(C) B.E Act may kindly be started against the arrested accused person namely Shahar Gope (35) S/o Hazari Gope of Vill- Madhuban, PS Hura, Dist. Purulia and arrange for its investigation.
