Sub: - Complaint against Nabin Mahato (43) S/o Lt. Bhudar Mahato of Vill- Siju Makhna, PS Hura, Dist. Purulia to start a cog case U/S-46A(c) B.E. Act.

Sir,

In producing here with arrested accused namely Nabin Mahato (43) S/o Lt. Bhudar Mahato of Vill- Siju Makhna, PS Hura, Dist. Purulia along with seized Country Spirit bottles DILKHUSH (details of seized articles are mentioned in attached seizure list), I beg to submit that today on 12.10.18 at 17.45 hrs received a credible source information and according to that information I, SI Swapan Majumdar along with force held raid (18.35 hrs.- 19.15 hrs) in the house of above noted accused person at Siju Makhna village under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling country spirit which was kept in his house. On demand, he failed to produce any valid documents/ License in respect of selling and stocking Country Spirit. Accordingly, I seized all the sealed Country Spirit bottles (details in attached seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample one bottle. Then I, arrested him after preparing proper arrest memo, maintained all formalities regarding arrest as he committed offence U/S 46A(C) B.E. Act and supplied one copy to him. This is to note here that on seeing police party all public/customers fled away. Total 28 (Twenty eight) bottles country spirit (DILKHUSH) measuring 600 ML each bottle value Rs- 35/- each Total Value Rs- 980/-

Under the above circumstances and fact, I therefore pray that a Cog. Case U/S 46A(C) B.E Act may kindly be started against the arrested accused person namely Nabin Mahato (43) S/o Lt. Bhudar Mahato of Vill- Siju Makhna, PS Hura, Dist. Purulia and arrange for its investigation.
