Sir,

In producing here with arrested accused namely Manik Mondal (40) S/o Bhudeb Mondal of Vill- Kalaboni, PS Hura, Dist. Purulia along with seized Country Spirit bottles DIL SE & DILKHUSH (details of seized articles are mentioned in attached seizure list), I beg to submit that today on 26.10.18 at 17.25 hrs during my Evening Mobile duty received a credible source information and according to that information I, SI Biswajit Sarkar along with force held raid (18.05 hrs.- 18.25 hrs) in the shop of above noted accused person at Kalaboni village under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling country sprit which was kept in his shop. On demand, he failed to produce any valid documents/ License in respect of selling and stocking Country Spirit. Accordingly, I seized all the sealed Country Spirit bottles (details in attached seizure list) after preparing proper seizure list duly signed by the accd. person & witnesses and labeled sample one bottle each. Then I, arrested above noted accd. person after preparing proper arrest memo, maintained all formalities regarding arrest as he committed offence U/S 46A(C) B.E. Act and supplied one copy to him. This is to note here that on seeing police party all public/customers fled away. Total 37 (Thirty Seven) bottles country sprit 25 bottles (DIL SE) measuring 600 ML each bottle value Rs- 35/- each and 12 bottles (DIL KHUSH) measuring 375 ML each bottles value Rs. 22 each have been seized. Total Value Rs- 1139/-

Under the above circumstances and fact, I therefore pray that a Cog. Case U/S 46A(C) B.E Act may kindly be started against the arrested accused person namely Manik Mondal (40) S/o Bhudeb Mondal of Vill- Kalaboni, PS Hura, Dist. Purulia and arrange for its investigation.
