

Sub:- Prayer for starting a specific case.

Sir,

In producing herewith 02 (two) arrested accd. persons namely i) Abdul Kalam Ansary S/o Salim Ansary of Chatuhasa, Mahultard, PS- Arsha, Dist- Purulia, driver of vehicle No- WB55A/5650, Chassis No- MAT466395G1K22929 and Engine No- 61K63548218 and ii) Jakir Sha S/o Sahid Sha of Digudih Para, PS- Purulia (T), Dist- Purulia, driver of vehicle No- WB55A/5650, Chassis No-MAT466457J5D10950, Engine No- 81C84468446. I, SI Biswajit Sarkar would like to draw your kind attention that, as per your kind direction I along with force had been performing Naka checking duty in front of Pather Sathi on NH60A Road (Purulia-Bankura) since 11:00 hrs. We were checking all the vehicles as well as the papers of those vehicles running through there. During my checking duty at 13.15 hrs. I managed to stop a vehicle bearing Regd. No- WB55A/5650 and asked for driver to produce documents in respect of said vehicle but he failed to give any valid documents in respect of said vehicle and loaded goods. In this regard I detained the vehicle for the sometime to verify the vehicle. After some time at 13.45 hrs. during my that duty I also stop one another vehicle which was coming from Purulia side with holding same Registration number. I detained the same and also asked the driver to produce documents but he also failed to give any documents in respect of the said vehicle and loaded goods. On being asked about the papers of the vehicles they could produce nothing. About the procurement of those vehicles as well as the assimilation of the registration Nos of those vehicles they stated incoherently. They also kept mum regarding the destination and purpose of their journey. From their statements it is crystal clear that they procured those vehicles by means of theft or by fraudulent means and those vehicles are stolen properties indeed. They also took the policy of cheating by affixing fake number plate to have an escape from all by giving a genuine outlook of those vehicles. Accordingly I seized the both vehicles of same registration number i.e. i) vehicle No- WB55A/5650, Chassis No- MAT466395G1K22929 and Engine No- 61K63548218 loaded with Sponge Iron dust and ii) vehicle No- WB55A/5650, Chassis No-MAT466457J5D10950, Engine No- 81C84468446 loaded with Sponge Iron in between 14.15 hrs. and 15.15 hrs. after preparing proper seizure list duly signed by the witnesses & drivers of the both vehicles.. After seizure I arrested both drivers namely i) Abdul Kalam Ansary S/o Salim Ansary of Chatuhasa, Mahultard, PS- Arsha, Dist- Purulia and ii) Tahir Sha S/o Sahid Sha of Digurdih Para, PS- Purulia (T), Dist-Purulia maintained all formalities regarding their arrest. I also issued check list against all of them as per guideline. Brought them to PS and put into PS Lock up after observing all formalities of Hazat rules and seized both vehicles kept into PS compound.

Under the above circumstances and fact, I therefore pray that a Cog. Case may kindly be started against the arrested accused persons i) Abdul Kalam Ansary S/o Salim Ansary of Chatuhasa, Mahultard, PS- Arsha, Dist- Purulia and ii) Tahir Sha S/o Sahid Sha of Digudih Para, PS- Purulia (T), Dist- Purulia and the owners of the said both vehicles as per proper section of law and arrange for its investigation.
