Respected Sir,

In producing here with the arrested accused person namely Swapan Mahato (42 yrs.) S/O Jagabondhu Mahato of Vill.- Guridih , P.S. Jhalda, Dist. Purulia along with seized 15 sealed Country Spirit bottles of "DIL KHUSH"(details of seized article is mentioned in attached seizure list). I beg to submit that today during E/P duty at about 18:15 hrs I received a credible source information that one person namely Swapan Mahato (42 yrs.) S/O Jagabondhu Mahato of Vill.- Guridih , P.S. Jhalda, Dist. Purulia is selling Country Spirit bottles from his house . Accordingly, I along with force left for Guridih village to work out the said source information. Then at about 18:45 hrs, we reached at Guridih Village and found the above noted person was selling Country Spirit bottles from his house. I like to note here that seeing the police party customers fled away. Accordingly, I searched & seized 15 sealed Country Spirit bottles of "DIL KHUSH" (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled. Total 09 liter Country Spirit has been seized. I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him.

Under the above circumstances , I therefore pray before you that a cog case may kindly be started U/S 46A(C)B.E. Act 1909 against the arrested accused person namely Swapan Mahato (42yrs.) S/O Jagabondhu Mahato of Vill.- Guridih, P.S. Jhalda, Dist. Purulia and arrange for its investigation.
