Sir,

In producing here with arrested accused persons namely- (1) Samiul Khan @ Kismat (35 yrs) S/O-Lt. Sk. Azad, (2) Jariful Khan (30 yrs) S/O- S/O-Lt. Sk. Azad, (3) Abrar Kazi (24 yrs) S/O-Aslam Kazi all are of Vill. Hussainidih, PS-Jhaldia, Dist-Purulia along with seized articles- (i) Two BHOJALL, (ii) two Crowbar, (iii) one Bamboo stick and (iv) one Torch Light, I beg to lodge complaint to the effect that in the night of 21.10.18 I along with C/886 Subendu Saha, C/300 Aiy Krishna Roy & C/696 Gorapada Paul was performing Night Patrolling duty within the P.S. area through Gov. vehicle bearing Regn. No. WB 55/6183. This refers to Jhaldia P.S. C.C. No. 3166/18 Dtd: 23.10.18 & Jhaldia P.S. GDE No. 758 Dtd: 21.10.18. At that time, I received a credible source information at about 21.15 hrs that some unknown miscreants are preparing themselves to commit dacoity at 'Gola Road Petrol Pump' being assembled near Mahato Bandh which situated just beside the said Gola Road, under Jhaldia P.S. Accordingly, I returned to P.S. and subsequently left P.S. to workout the said source information with additional force (A.S.I. Paulraj Kr. Gupta, LNK-600 Moniram Thapa, RM-1471 Dipesh Thapa) noting the fact in G.D. which refers to Jhaldia P.S. GDE No. 763 Dtd: 22.10.18.

Then, myself along with accompanied officer and force reached near Mahato Bandh and stop the vehicle by the side of Gola Road keeping distance approx 50 meters from Mahato Bandh. After that, we started to proceed towards Mahato Bandh on foot and when we reached near the Mahato Bandh, found 11-15 persons sitting by the side of a bush (in between Mahato Bandh and Gola Road) whispering each others. Their voice was clearly audible to us due to late night & the place was silent zone. They were planning to commit dacoity at the nearby Petrol Pump which is locally known as 'Gola Road Petrol Pump'. After confirmation, we encircled the area secretly and loudly disclose our identity with a direction to surrender before us. But, all of them tried to run away seeing the police party. However, we manage to apprehend 03 (three) out of them after a hot chase. Accordingly, I interrogate them thoroughly where they disclosed their identity as Samiul Khan @ Kismat S/O-Lt. Sk. Azad, Jariful Khan S/O- Lt. Sk. Azad, Abrar Kazi S/O-Aslam Kazi all are of Vill-Hussainidih, PS-Jhaldia, Dist-Purulia and also confessed that they along with Sk. Abhis S/O Sk. Jallil of vill. Kantadih, P.S. Jhaldia, Dharna Kumar S/O Bhaghat Kumar of vill. Belajidih, P.S. Kotshila, Monoranjan Kumar @ Malar S/O Dwarik Kumar of vill. Jaratara (Tola Beldih), P.S. Kotshila, Aswini Kumar S/O Bholanath Kumar of vill. Jaratara (Tola Beldih), P.S. Kotshila, Dulal Bouri @ Mebra S/O Lt. Daburu Bouri of vill. Pat Jhaldia, P.S. Jhaldia, Sk. Insof @ Meja S/O Yasar Muhammad of vill. Kantadih, P.S. Jhaldia, Sk. Kahu S/O Sk. Abul Kasem of vill. Kantadih, P.S. Jhaldia, all are of Dist. Purulia and 04 (four) others being armed with deadly weapons were gathered to prepare themselves for committing dacoity at the nearby Petrol Pump. Accordingly, I arrest them after prepared proper arrest memo. On search, we recovered and seized the following weapons after preparing proper seizure list & labels duly signed by the witnesses - (1) Two BHOJALL, (ii) two Crowbar, (iii) one Bamboo stick and (iv) one Torch Light. I like to note here that due to odd hours of night no public witnesses was available at that time.

Kotshila, (7) Aswini Kumar S/O Bholanath Kumar of vill. Jaratara (Tola Beldih), P.S. Kotshila, (8) Dulal Bouri @ Mebra S/O Lt. Daburu Bouri of vill. Pat Jhaldia, P.S. Jhaldia, (9) Sk.
