Respected Sir,

In producing here with the arrested accused person namely Kalipada Majhi (42 yrs.) S/O Paltu Majhi of Vill.- Mahatomara, P.S. Jhalda, Dist. Purulia along with seized 20 sealed Country Spirit bottles of "DIL KHUSH" (details of seized article is mentioned in attached seizure list). I beg to submit that today during anti crime patrolling duty at about 16:25 hrs, I received a credible source information that one person namely Kalipada Majhi S/O Paltu Majhi of Vill.- Mahatomara, P.S. Jhalda, Dist. Purulia is selling Country Spirit bottles from his house. Accordingly, I along with force left for Mahatomara village to work out the said source information. Then at about 16:55 hrs, we reached at Mahatomara Village and found the above noted person was selling Country Spirit bottles from his house. I like to note here that seeing the police party customers fled away. Accordingly, I asked him to produce valid license in respect of selling Country Spirit bottles but he failed through sufficient time was given. Then, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. After that, I searched & seized 20 sealed Country Spirit bottles of "DIL KHUSH" (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled. Total 12 liter Country Spirit has been seized.

Under the above circumstances, I therefore pray before you that a cog case may kindly be started U/S 46A(C) B.E. Act 1909 against the arrested accused person namely Kalipada Majhi (42 yrs.) S/O Paltu Majhi of Vill.- Mahatomara, P.S. Jhalda, Dist. Purulia and arrange for its investigation.
