In producing here with the following arrested accused persons namely (i) Meghnath Sing Sardar(30 yrs) S/O Srabon Sing Sardar of village- Bhursatanr, PS- Kashmar, Dist- Bokaro, (ii) Amit Mahato (20yrs) S/O Aswani Mahato of vill. Khairi, P.S. Kotshila, Dist. Purulia, (iii) Sunil Kumar (26yrs) S/O Ram Charan Kumar of vill. Majhidih, P.S. Kotshila, Dist. Purulia along with 03(three) seized Tractors- (i)Mahindra B275 DI TU MKM DLX (Engine No- NJC2EAZ0688 & Chassis No- MBNABAEXPJJO1560), (ii) Mahindra B275 DI TU MKM DLX (Engine No- RJD2DBN5379 & Chassis No- MBNAAADBPJRD00315) (iii)EICHER388 (Engine No- J1987E & Chassis No- 926513155932) , all are attached with a sand loaded trolley, the fact in brief is that today(29.10.18) evening at about 16:15 hrs received a credible source information that few tractors was carrying sand illegally and coming from Shyamnagar Ghat & going towards Jhalda side. Accordingly, myself along with force left PS to work out the said source information. This refers to Jhalda PS GDE No- 1078 Dated- 29/10/18 & Jhalda PS CC No- 3232 Dated- 29/10/18. Then, we intercept the said vehicles near Kushi Railway Gate (under Jhalda PS) at about 17:25 hrs and found the above noted tractors were tagged with a trolley each being loaded with sand. On asked, the drivers disclosed their identity as mentioned earlier. On demand, all of them failed to produce any valid papers in respect of the Tractors which are attached with a Trolley as well as loaded sand though sufficient time was given. During interrogation, the drivers of the said tractors confessed that they in convince with the respective owners of said seized Tractors & others is carrying the said sand after received dishonestly from the bank of river Subarnarekha at Shyamnagar Ghat (which is not a registered Ghat) & carry on in conceal it as stolen property for aiming business to deal for profit as habitually. Then, I SI Gagan Baisnab arrested the following accused drivers of said vehicles (as disclosed during interrogation)- (i) Meghnath Sing Sardar(driver of the tractor Mahindra B275 DI TU MKM DLX having Engine No- NJC2EAZ0688 & Chassis No- MBNABAEXPJJO1560) S/O Srabon Sing Sardar of village- Bhursatanr, PS- Kashmar, Dist- Bokaro, (ii) Amit Mahato (driver of the tractor Mahindra B275 DI TU MKM DLX having Engine No- RJD2DBN5379 & Chassis No- MBNAAADBPJRD00315) S/O Aswani Mahato of Vill. Khairi, P.S. Kotshila, Dist. Purulia, (iii) Sunil Kumar (driver of the tractor EICHER388 having Engine No- J1987E & Chassis No- 926513155932) S/O Ram Charan Kumar of Vill. Majhidih, P.S. Kotshila, Dist. Purulia under proper arrest memo and also seized the Tractors- (i)Mahindra B275 DI TU MKM DLX (Engine No- NJC2EAZ0688 & Chassis No- MBNABAEXPJJO1560), (ii) Mahindra B275 DI TU MKM DLX (Engine No- RJD2DBN5379 & Chassis No- MBNAAADBPJRD00315) (iii)EICHER388 (Engine No- J1987E & Chassis No- 926513155932) with attached sand loaded Trolley(approx 100 cft) each.

On return to P.S., Put the arrested accused persons into the P.S. Lock UP after maintaining all formalities, kept the sand loaded seized vehicles at PS compound and I do here by submitting written complaint before you to start a cog case against (i) Meghnath Sing Sardar(30 yrs) S/O Srabon Sing Sardar of village- Bhursatanr, PS- Kashmar, Dist- Bokaro, (ii) Amit Mahato (20yrs) S/O Aswani Mahato of vill. Khairi, P.S. Kotshila, Dist. Purulia, (iii) Sunil Kumar (26yrs) S/O Ram Charan Kumar of vill. Majhidih, P.S. Kotshila, Dist.
