I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Gurupada Kumar, S/O- Lt.Falari Kumar of village + P.O-Barabendya, P.S-Joypur, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 29.10.2018 at about 02.10 PM I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 1. Sristidhar Mahato, HG.TSH and 2. Haragobinda Singh Mura(OE) entered the premises of Gurupada Kumar, S/O- Lt. Falari Kumar of village + P.O-Barabendya, P.S- Joypur, Dist- Purulia, and found Gurupada Kumar was enjoying electricity unauthorizedly drawing power from LTOH line of WBSEDCL through copper(Cu) cable red and white colour by means direct hooking to his house premises and connected load found 0.235 KVA. As Gurupada Kumar, S/O- Lt. Falari Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Sristidhar Mahato, HG TSH and 2. Haragobinda Singh Mura(OE). The inspection team left the premises at 2.25 PM.
