Respected Sir,

In producing herewith arrested accused namely Sadhan Karmakar (60 yrs), S/O- Lt Prabodh Karmakar of vill – Talajuri, PS - Kashipur, Dist- Purulia along with seized articles, I beg to report that on 14.10.18 in course of mobile duty myself along with force got reliable source information that one person is selling country liquor at village Mrigipahari in his house under Kashipur PS. To work out the information I A.S.I. Jayanta Chakraborty along with C/413 Bijoy Goswami, C/961 Himangshu Sannigrahi, reached at Talajuri village at about 18:55 hrs and found that one person was selling C.S. liquor in his house. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling C.S. liquor in his possession. So the above noted accused has committed an offence u/s - 46(A)(c) B.E. Act 1909 Amended up-to date. During search I found (1) 19 (Nineteen) sealed bottles of DILKHUSH brand C.S. liquor (600 ml) (2) 04 (Four) empty bottles of DILKHUSH C.S. (3) 05 (Five) Plastic Glass (4) Rs. 60/- (Sixty) as sale proceed seized the above noted articles under proper seizure list duly signed by the witnesses in between 18:45 hrs. to 18:55 hrs. I also seized and labeled bottles with sample C.S. liquor at the spot in presence of accused person and witnesses .Accordingly I arrested the above noted accused person u/s - 67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with seized above noted articles.

Therefore I pray before you that kindly arrange to start a specific case under proper section of law u/s 46(A)(c) B.E. Act 1909 against arrested accused Sadhan Karmakar (60 yrs), S/O- Lt Prabodh Karmakar of vill – Talajuri, PS - Kashipur, Dist- Purulia and arrange for its investigation.
