Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Tapan Banerjee S/O Aswini Banerjee Vill- Modapatra PO- Tara Dist-PURULIA has committed theft of Electricity U/S 135(1)(a) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 10.10.2018 I received a secret complain over telephone that Sri Tapan Banerjee S/O Aswini Banerjee Vill- Modapatra PO- Tara Dist-PURULIA consuming electricity by means of tapping from service cable before entering the Meter.

On the basis of said complaint at about 3.50 pm. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

- 1) Sri Sanjoy Garain, OE Kashipur CCC
- 2) Pradip KR. Modak, HG, TSH, Kashipur CCC.

Entered the premises of Sri Tapan Banerjee Dist-PURULIA and found that Sri Banerjee consuming electricity dishonestly by means of tapping from service cable before entering the Meter to resist actual energy consumption..Then we disconnect his service line,seized the PVC cable(tapping point) 1.5 metre . Load found-fan-4 , cfl-6 nos, TV- 1 Nus Total-0.62 KW.

After preparation of proper seizure list The seizure list are prepared at the site and the accused person refuse to sign in the seizer list. The inspection team left the above premises at about 4.25 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
