I, ASI Nehal Ch. Mandal S/O Lt. Balaram Mandal of Vill - Kendua P.S - Hiramulh Dist- Bankura, At present ASI of Kendu police station Dist- Purulia. do hereby lodge this FIR as suomota against arrested accd persons 1) SK Nishar Hossain @ SK Millon S/O SK Khalid @ MD Ishaque of village Natungram P.O. Paikuni P.S - Ilambazar Dist- Birbhum 2) Abdul Maleque S/O Lt. SK Isam of Vill. Gharisha P.O- Gharisha P.S - Ilambazar Dist- Birbhum 3) SK Amar Ali (Driver of Vehicle No - WB-47-2055) S/O SK Maniruddin of village Natungram P.O. Paikuni P.S - Ilambazar Dist- Birbhum to the effect that On (30.09.18) during Anti crime mobile duty at around 14.15 hrs while myself along with forces was performing mobile duty on Purulia-Manbazar High road at that time found one vehicle bearing no- WB-47-2055 (Pick-up van) was Coming from Talal Hat side and was going towards Manbazar Side with excessive speed. On seeing police party the driver tried fled way towards makarka village under Kendu P.S but somehow we managed to intercepted the vehicle at Makarka village under Kendu P.S and found one person was on the driver's seat namely 1) SK Amar Ali (Driver of Vehicle No - WB-47-2055) and another two persons was inside him namely 2) SK Nishar Hossain @ SK Millon 3) Abdul Maleque. In their present I found that the vehicle bearing no- WB-47-2055 (Pick-up van) was loaded 07 (seven) numbers of Cows were kept tail with rope through legs and neck and pushing them in the above noted vehicle for selling in cruel manner. So that they cannot move freely. On asked they disclosed their identity as noted above (Sl. No. 1 and 2 as assistant and Sl. No. 3 is the Driver of Vehicle) but their identity could not be verified. On demand they could not produce any papers in respect of the vehicle as well as the seven Cows and about the procurement of the cartles as well as the vehicle they stated incoherently and from their statements there is every ground to believe that they have procured the vehicle and the cartles from Talal hat in any fraudulent means or by means of theft and was trying to conceal those and they are habituated offender in such offense with a view to sale the same at Ilambazar cattle hat Dist- Birbhum in high price.

The above noted accd persons treated the cartles in such a manner so as subject those to unnecessary pain as they loaded those in such a vehicle which does not measure sufficiently either in height, length or breadth. Hence I seized those seven Cows and the vehicle bearing no WB-47-2055 from 14:55 hrs to 15:45 hrs from the possessions of the above noted accd persons under proper seizure list where the description of each cow is mentioned and after seizure I arrested them. It is to be noted that the place being remote no public witness could be made available and hence my accompanying police forces stood witnesses. After that I brought the arrested accd persons, seized vehicle and the seized cows to PS. Hence I pray kindly treated as FIR as per law.
