I beg to submit that today (11.10.18) in between 17.45 hrs to 18.05 hrs a raid was conducted in the Pan Stall of Kalipada Mahato S/O Lt Satrughan Mahato of village Chayadih, P.S. – Kotshila Dist – Purulia located at Kotshila Railway Station course of my raid duty on acting of secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling country spirit which was kept in pan stall.
