Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. Person namely Bablu Bouri (38) S/O- Badyakar Bouri of village Bichhedpara, PS-Neturia, District- Purulia with seizure of (1) 08 pcs. Sealed bottles of Dil Se country spirit containing 600 ml. each and (2) 06 pcs. Sealed bottles of Captain Country spirit containing 600 ml. each, which were seized under proper seizure list.

I beg to submit that today (05.10.18) in between 18.15 hrs to 19.15 hrs. a raid was conducted in the house of Bablu Bouri (38) S/O- Badyakar Bouri of village Bichhedpara, PS-Neturia, District- Purulia on acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling liquor which were kept in his house, on demand Bablu Bouri failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents . As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also (1) 08 pcs. Sealed bottles of Dil Se country spirit containing 600 ml. each and (2) 06 pcs. Sealed bottles of Captain Country spirit containing 600 ml. each which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Bablu Bouri (38) S/O- Badyakar Bouri of village Bichhedpara, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1. C/78 Utpal Sarkar, 2. C/66 Kameshwar Pandey & 3. C/382 Bipad Taran Chattarjee all of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Bablu Bouri (38) S/O- Badyakar Bouri of village Bichhedpara, PS-Neturia, District- Purulia under proper section of law.
