- 1) That the complainant is a permanent resident of vill. Janardandih, within P.S. Neturia Dist Purulia and within the jurisdiction of this court. *Plot P. Post P.S. Purulia (D) near Zila School More Sans Group Flat no - 102*
- 2) That the complainant is one of the recorded owner of the land and building situated in Mouza *Janardandih* recorded in L.R. Khatian no. 249, C.S.Plot No. 196, R.S. Plot no.143, Area 8 dec. and an old one storied Pucca building covered area of 750 sq.ft.
- 3) That in the year 2016 the accused person no.1 by virtue of a regd. sale deed bearing no. 1968 sold away the aforesaid entire land and building to the accused person no.3 without the consent of the complainant and the accused person no.1 has no right to sell the entire land and building to the accused person no. 3, and as

such the accused person no. 1 in collusion with the other accused persons cheated the complainant.

4) That be it mentioned here that the aforesaid land and building was recorded in the name of the mother of the complainant, but in the year 1989 the accused person no. 1 on taking a false plea to the complainant and on giving false assurance to the mother of the complainant saying that a loan will be sanctioned from a Bank, So land will be requested to be transferred in the name of the complainant and accordingly the mother of the complainant in the year 1989 by virtue of a Regd. sale deed bearing no. 5084 sold away the land in favour of the complainant and in the said sale deed the accused person no. 1 has cited as one of the witnesses.

5) That thereafter in the year 2004 the accused person no. 1 in collusion with the accused person no. 2 without the consent and permission of the mother of the complainant and the complainant and by false thumb impression of the mother of the complainant on the sale deed in her absence and by writing by the pens of the complainant

in the name of the accused person no.1 on the said sale deed sold away the land to the accused person no. 2 and curiously enough in the year 2009 the accused person no.2 sold away the said land to the accused person no.1 without any money transaction.

6) That thereafter in the year 2012 the accused person no.1 by collecting some photos of the complaint and by false giving promise purchased the said land by virtue of a regd. sale deed bearing no.468 and then the accused person no.1 without the consent and permission of the complainant he by virtue of a regd. sale deed being no. 1968 dated 21/11/2017 sold away entire land to the accused person no.3 and the accused person no.1 has no right to sell the entire land to the accused person no.3.

7) That the complaint reported the matter before O/C Neturia P.S. by registered post with A/D on 18-7-18 but the police did not take any action against ~~maxand~~ the accused persons and then the complaint reported the matter to S.P. ,Purulia on 17.7.18 but of no good.
