Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. Person namely Nibas Gorai (30) S/O- Sankar Gorai of Vill- Bhamuria, PS-Neturia, District- Purulia with seizure of (1) 02 pcs. Sealed bottles of officer choice containing 180 ml each (2) 02 pcs. Sealed bottles of Mcdowell's (Rum) containing 180 ml each (3) 05 pcs. Sealed bottles of Dil Khush Country Sprit containing 375 ml each (4) 02 pcs. Sealed bottles of Dil Khush Country Sprit containing 600 ml each and (5) 10 pcs. Sealed bottles of captain Country Sprit containing 600 ml each, which were seized under proper seizure list.

I beg to submit that today (10.10.18) in between 18.55 hrs to 20.05 hrs. a raid was conducted in the shop of Nibas Gorai (30) S/O- Sankar Gorai of Vill- Bhamuria, PS-Neturia, District- Purulia on acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling liquor which were kept in his shop, on demand Nibas Gorai failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents . As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also (1) 02 pcs. Sealed bottles of officer choice containing 180 ml each (2) 02 pcs. Sealed bottles of Mcdowell's (Rum) containing 180 ml each (3) 05 pcs. Sealed bottles of Dil Khush Country Sprit containing 375 ml each (4) 02 pcs. Sealed bottles of Dil Khush Country Sprit containing 600 ml each and (5) 10 pcs. Sealed bottles of captain Country Sprit containing 600 ml each which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Nibas Gorai (30) S/O- Sankar Gorai of Vill- Bhamuria, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1. C/1140 Dayamoy Mahato and 2. C/1224 Gajan Murmu both of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Nibas Gorai (30) S/O- Sankar Gorai of Vill- Bhamuria, PS-Neturia, District- Purulia under proper section of law.
