Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. Person namely Mansuri Chowdhury (45) S/O- Lt. Bundi Chowdhury of Vill- Parbelia Hattola, PS-Neturia, District- Purulia, P/A- Vill-Khojatol, PO- Kharakdiha, PS- Deori, Dist-Giridih, Jharkhand with seizure of (1) 10 pcs. Sealed bottles of Dil Khush Country Sprit containing 375 ml each and (2) 06 pcs. Sealed bottles of captain Country Sprit containing 600 ml each, which were seized under proper seizure list.

I beg to submit that today (26.10.18) in between 19.05 hrs to 20.05 hrs. a raid was conducted at Parbelia Bazar in the shop of Mansuri Chowdhury (45) S/O- Lt. Bundi Chowdhury of Vill- Parbelia Hattola, PS-Neturia, District- Purulia, P/A- Vill-Khojatol, PO- Kharakdiha, PS- Deori, Dist-Giridih, Jharkhand on acting of a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found that the above noted person was keeping / selling liquor which were kept in his shop, on demand Mansuri Chowdhury failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents . As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also (1) 10 pcs. Sealed bottles of Dil Khush Country Sprit containing 375 ml each and (2) 06 pcs. Sealed bottles of captain Country Sprit containing 600 ml each which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Mansuri Chowdhury (45) S/O- Lt. Bundi Chowdhury of Vill- Parbelia Hattola, PS-Neturia, District- Purulia, P/A- Vill-Khojatol, PO- Kharakdiha, PS- Deori, Dist-Giridih, Jharkhand has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1. C/382 Bipad Taran Chatterjee 2. C/1001 Soumendu Das and 3. C/1303 Biswanath Majhi all of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Mansuri Chowdhury (45) S/O- Lt. Bundi Chowdhury of Vill- Parbelia Hattola, PS-Neturia, District- Purulia, P/A- Vill-Khojatol, PO- Kharakdiha, PS- Deori, Dist-Giridih, Jharkhand under proper section of law.
