In producing herewith one arrested accd. person namely Amit Kumar saw (22yrs) S/o Prem Sagar Prasad Saw of Village- Gola, PS- Gola, Dist- Ramgarh, (Jharkhand) A/P Village- Chinpina, (Raghunathpur C.S Shop No. 2) PS- Raghunathpur, District - Purulia with seized 22 (Twenty Two) sealed bottles of Country Spirit styled as "Dil Se" each Bottle contains 375ml which 01 (One) bottle collected as sample, which was seized & level under proper seizure list.

I beg to submit that today (16.10.2018) during my mobile duty as well as raid duty in between 13.45 hrs to 14.05 hrs acting on a source information held raid on the bank of pond Surigaria at Bhagabandh under Para PS, Dist- Purulia and found that the above noted person was keeping and selling Country Spirit which were kept near the pond in a bush. On being asked he failed to produce any valid document in respect of keeping and selling of said liquor. As such I seized 22 (Twenty Two) sealed bottles of Country Spirit styled as "Dil Se" each Bottle contains 375 ml in which 01 (One) bottle kept as sample, under proper seizure list in presence of witnesses duly signed by them & labeled the same. I also arrested the above noted accd. person namely Amit Kumar saw S/o Prem Sagar Prasad Saw of Village- Gola, PS- Gola, Dist- Ramgarh, (Jharkhand) A/P Village- Chinpina, (Raghunathpur C.S Shop No. 2) PS- Raghunathpur, District - Purulia after observing all legal formalities.

The above noted arrested accd. namely Amit Kumar saw S/o Prem Sagar Prasad Saw of Village- Gola, PS- Gola, Dist- Ramgarh, (Jharkhand) A/P Village- Chinpina, (Raghunathpur C.S Shop No. 2, PS- Raghunathpur, District - Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of country spirit.

Under the above fact and circumstance I pray that a case may kindly be started under proper section of law against Amit Kumar saw S/o Prem Sagar Prasad Saw of Village- Gola, PS- Gola, Dist- Ramgarh, (Jharkhand) A/P Village- Chinpina, (Raghunathpur C.S Shop No. 2) PS- Raghunathpur, District - Purulia and arrange for its investigation.
