In producing here with the arrested accused Sk. Jahangir S/o Nur Islam of village- Sankra "B", PS- Para, Dist- Purulia and one seized improvised country made firearm having length 10 inch approx from butt to barrel, 6 inch barrel, having firing pin and trigger along with one(01) round ammunition. Today on 18.10.18 at 16:55 hrs leading to the confessional statement of the arrested accused Sk. Jahangir S/o Nur Islam of village- Sankra "B", PS- Para, Dist- Purulia I SI Sibsankar Pal along with force left PS with arrested accused to recover stolen articles in c/w Para PS Case No 116/18 dated 18.10.2018 U/S 461/379<sup>323</sup>/IPC. I along with force hold a thorough search in the father-in-law's house of the above noted accused person at Hariharpur village under Para PS as he is residing at his father-in-law's house since long. During search from the bundle of bedding recovered one improvised country made firearm in the room of accused Sk Jahangir. On asked he could not able to produce any license or valid document in respect of possessing that improvised fire arms. Accordingly I seized the improvised country made firearm and One (01) rd ammunition from the possession of the arrested accused person Sk. Jahangir under proper seizure list in presence of witnesses duly signed by them.

Under the above circumstances I pray before you for starting a case under proper section of law against accused Sk. Jahangir S/o Nur Islam of village- Sankra "B", PS- Para, Dist- Purulia for possessing improvised country made fire arms and arrange for its investigation.
