of para Tharagona Sambajoni Durgapuja committee that 03 miscreants entered into the Kalitemple attached to Durga temple and taken away some ornaments and other articles of i.e. microphone, D.J light etc. over this (Blissus 60/70 unidentified villagers of para & its adjoining villages blocked Dubna. Jhapna road approx 50 mtrs away from PS, at about 07:05 hrs. Myself along with ASI I. Chakraborty, ASI A. Goinai along with force reached to the spot and asked them to withdraw the road blockade as it is an important road & many people facing problem to pass during this Durgapuja season. But they did not pay any heed. They misbehaved with all the police personnel by using filthy languages and also pushed back police persons & they hit them ^{by fist & blows.} Resulting which some police personnel received injuries on their persons.

As they after forming unlawful assembly obstructed govt duty and caused injuries to the police persons, they are liable for punishment u/s 143/353/332/186 IPC.

Therefore I started this case suo-moto against 60/70 per unidentified persons of para & its adjoining villages. u/s - 143/353/332/186 IPC. SI Sudhin Kr. Mahato will investigate this case.
