I would like to inform you that today on 06.10.2018 at 11.55 hrs acting on a credible source information I ASI Purnendu Dutta along with ASI Punendu Banerjee, ASI Indrajit Chakraborty and force proceeded towards Rigudih Football ground under Para PS to arrest accused Mokim Ansary S/o Lalu Ansary of Vill, Righudi, PS, Para, Dist, Purulia in c/w Para PS Case No. 100/18 Date 19.09.2018 U/S 461/379 IPC. We reached near Rigudih Football ground at about 12.25 hrs. At about 13.05 hrs found that Mokim Ansary S/o Lalu Ansary was coming to Rigudih football ground. Seen the police party he stated to run away we chased him after a hot chased we managed to apprehend him. Just started interrogation suddenly the following persons namely 1) Akter Ansary S/o Lalu Ansary 2) Asiruddin S/o Sobabdi Ansary both of village Rigudih, PS- para, Dist- Purulia and 100 others rushed to the spot and started hot altercation which police personal and nabbed Mokim Ansary by assaulting police personal with fist and blows. Thus the above noted persons restrained public servant for discharging of their duty and also assaulted them.
