In producing herewith one arrested accd. person namely Panchu Bauri (50yrs) S/o Lt- Arun Bauri of Vill- Dhadkidih, PS- Para, District - Purulia with seized 23 (Twenty Three) sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml in which 01 (One) bottle collected as sample, which was seized & Invol under proper seizure list.

I beg to submit that today (12.10.2018) during my mobile duty as well as raid duty in between 20.45 hrs to 21.35 hrs acting on a source information held raid in the house of Panchu Bauri S/o Lt- Arun Bauri of Vill- Dhadkidih, PS- Para, District - Purulia and found that the above noted person was keeping and selling Country Spirit which were kept at his house. On being asked he failed to produce any valid document in respect of keeping and selling of said liquor. As such I seized 23 (Twenty Three) sealed bottles of Country Spirit styled as "DIL KHUSH" each Bottle contains 600 ml in which 01 (One) bottle kept as sample, under proper seizure list in presence of witnesses duly signed by them & labeled the same. I also arrested the above noted accd. person after observing all legal formalities.

The above noted arrested accd. namely Panchu Bauri S/o Lt- Arun Bauri of Vill- Dhadkidih, PS- Para, District - Purulia committed offence u/s 46 A(c) B.E. Act 1909 for unauthorized possession and sale of country spirit in his house.

Under the above fact and circumstance I pray that a case may kindly be started under proper section of law against Panchu Bauri S/o Lt- Arun Bauri of Vill- Dhadkidih, PS- Para, District - Purulia and arrange for its investigation.
