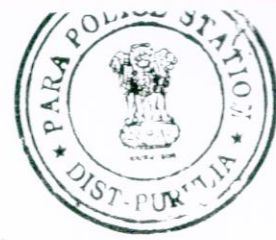

Sir,

In producing here with the arrested accused person Rajib Mahato (34 yrs) S/O- Lt Binod Mahato of Vill- Patharkunia, PS- Raghunathpur, Dist- Purulia and seized articles 1. Iron made angle 37 pcs each measuring approx 6 ft 2. ACSR wire length 150 ft which were seized from the house of Mokim Ansary S/O- Lalu Ansary of vill- Regudih, PS- Para, Dist- Purulia 3. 21 pcs iron made angle each measuring approx 6 ft which were seized from the house of Rajib Mahato S/O- Lt Binod Mahato of Vill- Patharkunia, PS- Raghunathpur, Dist- Purulia, I SI Sibsankar Pal do hereby lodge complaint against 1. Mokim Ansary S/O- Lalu Ansary of vill- Regudih, PS- Para, Dist- Purulia 2. Rajib Mahato S/O- Lt Binod Mahato of Vill- Patharkunia, PS- Raghunathpur, Dist- Purulia 3. Hafiz Ansary of vill- Jamua, PS- Raghunathpur, Dist- Purulia and 4. Majid Ansary of Vill- Hodla, PS- Raghunathpur, Dist- Purulia to the effect that the accd. Mokim Ansary was arrested on 10.10.2018 in c/w Para PS case No 111/18 dated 10.10.18 U/S 25(1-A)/27 Arms Act as he possessed an illegal improvised firearm. After his arrest during interrogation he stated that he would lead the Police to recover more firearms. As such he was forwarded before Ld Court with a prayer for 14 days PC. Ld court has granted 07 days PC for the said Mokim Ansary. Presently the accd Mokim Ansary is in PC in c/w Para PS case No 111/18 dated 10.10.18 U/S 25(1-A)/27 Arms Act.

On 12.10.2018 myself along with force arrived at the house of Mokim Ansary at Regudih village. He also accompanied with us. I conducted thorough search in and around the house of accd mokim Ansary. During the search I found that some iron made angles and a coil of ACSR wire were concealed under a heap of straw to the eastern side of the house of Mokim Ansary. On physical verification it was found that there were 37 pcs Iron made angles each measuring approx 6 ft and the coil of the ACSR wire length approx 150 ft. The measurement was done by the measurement tape which was with me in my investigation kitbox. Being asked Mokim Ansary failed to produce any document in support of the possession of those articles. I interrogated him thoroughly, then he confessed that he had procured the same by theft from various factories in Para, Raghunathpur and Neturia area. He also told the name of his associates as 1. Rajib Mahato S/O- Lt Binod Mahato of Vill- Patharkunia, PS- Raghunathpur, Dist- Purulia 2. Hafiz Ansary of vill- Jamua, PS- Raghunathpur, Dist- Purulia and 3. Majid Ansary of Vill- Hodla, PS- Raghunathpur, Dist- Purulia. being asked he stated that he sold those illegally procured items to Rajib Mahato S/O- Lt Binod Mahato of Vill- Patharkunia, PS- Raghunathpur, Dist- Purulia. I seized the articles under proper seizure list. As he is a terror in his village hence none came forward to stand as witness during seizure.

In this connection I would like to note here that previously Mokim Ansary¹ S/O- Lalu Ansary of vill- Regudih, PS- Para, Dist- Purulia was involved in the following cases which were charge sheeted after investigation.



1. Para PS Case No. 36/10 dtd. 07-05-10 U/S 395 IPC & 25/27 Arms Act.
2. Para P.S Case No. 49/11 Dt. 13/07/11 U/S 136(1) Electricity Act.
3. Para PS Case No. 66/14 dt. 12.06.14 U/S 395/397 IPC.

I also held raid in the house of Rajib Mahato accompanying with Mokim Ansary with assistance of officer and force of Raghunathpur PS, who was available in his house. I arrested him and searched his house in and around of his house thoroughly. During search 21 pcs iron made angle found lying at western side of his house concealed in a bush. Being asked he failed to produce any document for possessing those iron angles. After thorough interrogation he confessed that he had purchased those iron angles from Mokim Ansary. Mokim Ansary also identified those iron angles as he had sold those iron angles to Rajib Mahato. I seized those iron angles under proper seizure list. As it was late night hence none could be available for witness of seizure. I also held raid in the house of Hafiz Ansary of vill- Jamua, PS- Raghunathpur, Dist- Purulia and 3. Majid Ansary of Vill- Hodla, PS- Raghunathpur, Dist- Purulia but they could not be found available.

During enquiry it has been well established that the above noted persons are habituated in stealing iron angles and ACSR wire and other articles since long.

Therefore after producing the arrested accused person and seized articles at PS I pray that a case may kindly be started against 1. Mokim Ansary S/O- Lalu Ansary of vill- Regudih, PS- Para, Dist- Purulia 2. Rajib Mahato S/O- Lt Binod Mahato of Vill- Patharkunia, PS- Raghunathpur, Dist- Purulia 3. Hafiz Ansary of vill- Jamua, PS- Raghunathpur, Dist- Purulia and 4. Majid Ansary of Vill- Hodla, PS- Raghunathpur, Dist- Purulia under proper section of law.
