I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **JAINUL ANSARY, S/O- Late JABBAR ANSARY of VILL- KINISAYER, P.S.-PARA, Dist-Purulia**, the user of the electric has committed an offence of theft of electricity under section 135 (1) (b) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.


On 29.10.2018 at about 03:30PM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with Mr. Avishek Das, SAE(E),Dubra Para CCC, MrBilashChandra Mahato, Gr.I TSH of Dubra Para CCC and Mr. Alope Kr. Pandey,Gr.I TSH inspected the premises of **JAINUL ANSARY, S/O- Late JABBAR ANSARY of Village-KINISAYER, P.S.-Para, DistPurulia WBSEDCL**. During inspection it was found that the said **JAINUL ANSARY** was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 01 no LED, 01 no Bulb and 01 no stand fan, approx load 0.179 KW for domestic purpose, which is an offence u/s. 135 (1)(b) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 03:45PM.


As such **JAINUL ANSARY, S/O- Late JABBAR ANSARY of VILL- KINISAYER, P.S.- Para, Dist- Purulia** has committed an offence of theft of electricity under section 135 (1)(b) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
