In producing here with one arrested accd. person namely Brindaban Mahato (45 yrs) s/o Haripada Mahato of Vill-Bhuiyandih, PS- Purulia (M), District – Purulia with seizure list and seized articles. (1) 24 (twenty four) sealed bottles style as "DIL KHUSH" containing 600ml. as strength 80° UP each (2) Two bottles of "DIL KHUSH" 600 ml as empty 3) One bottle taken from SL No-1 as sample with proper seal and label.

I beg to submit that today (09.10.08) during mobile duty, myself along with force had been to village Bhuiyadih under PS Purulia (M) at 15:15 hrs. and found that one person keeping & selling liquor from a tea shop . Then myself along with force held raid in the Tea shop of said person Seeing the police party he tried to flee away but we managed to apprehended him and on being asked he disclosed his identity as Brindaban Mahato s/o Haripada Mahato of Vill-Bhuiyandih -Purulia (M), District- Purulia and stated that he is the owner of the said shop. On demanding he failed to produce any valid papers in support for keeping and selling of such liquor. On interrogation he confessed his guilty for selling and possession of country spirit styled as "DIL KHUSH". As such I seized 24 (Twenty four) sealed bottles style as "DIL KHUSH" containing 600 ml. as strength 80° UP each (2) Two bottles of "DIL KHUSH" 600 ml each as empty 3) One bottle taken from SL No-1 as sample with proper seal and label. Under proper seizure list in presence of witnesses and signed by witnesses and accused person. As he committed the offence punishable u/s 46 (A) (c) of B.E Act 1909. Hence I Arrested the above noted accused person after informing him & his relatives the ground of arrest and after observing all legal formalities. The process of seizure and arrest was done in between 15.45 hrs and 16.15 hrs.

Under the fact and circumstance kindly take necessary lawful action against Brindaban Mahato (45 yrs) s/o Haripada Mahato of Vill-Bhuiyandih, PS- Purulia (M), District – Purulia.
