I Sri Prashant Kishor, S/O - Kishori Prasad, A.E. & Station Manager of Telkalpara CCC of WBSEDCL do hereby lodge my complaint empowered by the Electricity(Amendment) Act-2007 to the effect that Om Prakash Ojha S/O Bhaktipada Ojha of Vill - Karcha, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) as detailed here under.

Today, i.e. on 27.10.2018 I, Prashant Kishor (AE&SM), along with Sri Chinmoy Maity, SAE(E), Sri Debdulal Banerjee, Sr.TSH of Telkalpara CCC, WBSEDCL conducted a raid programme at village Karcha under Purulia(M) P.S. When our team at about 10.00 A.M. entered to the Domestic premises of Om Prakash Ojha, we found that he was enjoying electricity dishonestly by means of Meter bypass by way of tampering service cable and run domestic appliances, thus original consumption was not recorded in meter and WBSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, Service connection with bypass wire dismantled and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 10.30 P.M. after completion of inspection & necessary formalities.

Om Prakash Ojha S/O Bhaktipada Ojha of Vill -Karcha, PS-Purulia(M) has committed theft of electricity under section 135(1)(b) of the Electricity(Amendment) Act-2007.
