Re: attempt to murder and beaten grievously with arms.

Sir.

This is to inform you that I, Nirmal Kumar Sharma, s/o - Shree Suganchand Sharma, having a residence at Chaabi biri Bagan, under ward no.- 15 P.O.-Purulia, P.S. – Purulia (Town), Dist. Purulia; hereby inform you that last night i.e. 16.10.2018 my elder brother namely - Pradeep Kumar Sharma, s/o - Shree Suganchand Sharma went out with his family members to visit puja pandels and after hopping puja pandels, my elder brother, after keeping his family members in our home, went for adda with his friends namely - Munu Rathi, Sanjay Singhodiya and ohers, at Karmi Dharamsala More, Shree Ram Mandir, B.B.Das Road, Purulia.

As per informed by my elder brother after getting his sense; at about 1 am on dated 17.10.2018, in that night some boys came to that spot of Karmi Dharamsala More, Shree Ram Mandir and among them one Tushar Awasthi, s/o -Chunnu lal Awasthi, residence at Dhunia Moholla, Old Police Line, ward no. 15, under the P.S. - Purulia(Town), whom I know very well as per our para's locality, suddenly started making video by his mobile phone, of conversations held by my elder brother - Pradeep Kumar Sharma and his friends and also threw filthy languages towards them. When Pradeep Kumar Sharma, my eider brother noticed that thing, he asked Tushar Awasthi the reason behind the video recording by his phone and also warned him to stop throwing slungs( gali galoj) but they did not paid any heed on this. Thereafter when my elder brother and his friends warned them about their misculture behaviour, that Tushar Awasthi came and sit near my elder brother, i.e. Prdeep Kumar Sharma and threatened my elder brother and his friends to keep quite otherwise he will beat them all very badly and also threatened to take the life of my elder brother, if he (Prdeep Kumar Sharma) utter any word for their act of behaviour. It is also came to know from my elder brother that they all are in state of drunken position and when my elder brother told him to go away from the spot that Tushar Awasthi suddenly charao on my elder brother and started to beat him and after seeing this, friends of my elder brother took initiative to stop him but Tushar Awasthi along with his friends became turned very arrogant and started beat them. During this, that Tushar Awasthi brings one bamboo (Bansh) piece and started to beat Pradeep Kumar Sharma (my elder brother) very badly. Suddenly, thereafter one of his friends, whose name can not recollect by my elder brother so far, clenched my elder brother i.e. Pradeep Kumar Sharma from behind and Tushar Awasthi with the help of that bamboo hit on the head of my elder brother i.e. Pradeep Kumar Sharma, by which he(Pradeep Kumar Sharma) suffered from grievous injury on his head and by this alleged act of commission, my elder brother fell down to the earth and immediately after this occurrence, that Tushar Awasthi charao on Pradeep Kumr Sharma (my elder brother) and bite on his(my elder brother) left chest by his teeth and for consequence of which a flesh came out from my elder brother's left chest and the marks of teeth deep into his(my elder brother) chest with an intention to cause death of him(my elder brother) and for consequence of alleged incidents Pradeep Kumar Sharma (my elder brother) became senseless for a while. Afterwards when he (my elder brother) getting back of his sense with the help of his friends present there, my elder brother came back to home at about mid night and went to the bed but again he lost his sense, and we thought of that he might have taken rest. When my elder brother recover his sense at about evening of that day, he narrated all the story to our family members and when he (my elder brother) started vomiting for the consequence of alleged injuries in his head, I took initiative to admit my elder brother in Sadar Hospital, Purulia and also informed about the alleged incident to the Town Police Station, Purulia, orally. After, all the examination held by doctor in Sadar Hospital, Purulia, they opined, this is the incident of neuron problems for which there is no proper equipments available at the Hospital in Purulia and they referred my elder brother to go out of station, for better treatment.

The delay of being lodging this unfortunate information before you for the consequence of medical hectic and hence, hereby I pray your good shelf to look upon the matter and do the necessary steps as earliest possible against Tushar Awasthi and others, for their act of alleged commission with an intention and also threatened to take life of my elder brother i.e. Pradeep Kumar Sharma and obviously which is also endanger for our family members by Tushar Awasthi and others, in future.
