Sub: Request for lodging F.I.R. against arrested accused Mohan Bhunia (40 Yrs) S/o-Lt Laxman Bhunia of Nodiha Bhuniapara , Ward no- 7, PS-Purulia (T) ,Dist- Purulia u/s- 46A(c) of B.E. Act 1909.

Sir,

In producing herewith arrested accused person Mohan Bhunia (40 Yrs) S/o-Lt Laxman Bhunia of Nodiha Bhuniapara , Ward no- 7, PS-Purulia(T),Dist- Purulia under Arrest Memo, Inspection Memo alongwith seized articles viz. (i) 25 (Twenty Five) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600ml of country spirit having strength 80° UP being sealed properly), (ii) 24 (twenty five) bottle of country spirit designed as Dil Se (each bottle contains 600ml of country spirit) one bottle of each Sl no- 1&2 sample (iii) 08 (Eight) pcs empty 'Dilse' bottles (iv) 05(four) plastic glasses, under proper seizure list and being labeled properly, I beg to report that today at 12.45 hrs received a telephonic information from source that one person namely Mohan Bhunia (40 Yrs) S/o-Lt Laxman Bhunia of Nodiha Bhuniapara , Ward no- 7, PS-Purulia(T) ,Dist- Purulia was selling country spirit at Nodiha bhuniapara illegally Accordingly after obtaining permission from O/C Purulia (T) PS. I Sl Subal Goswami alongwith SI Banshi Badan Mondal, C/202 Sandip Adhakar, C/353 Baidyanath Makherjee left PS for working out the information after diarizing the matter in GD vide Purulia (T) PS GDE No- 666 dated 12/10/18. We reached at Nodiha Bhuniapara and keeping the vehicle at a reasonable distance we proceeded to the house of said Mohan Bhunia as being shown by the source from distance. We entered in the house of Mohan Bhunia and found one person was selling liquor and some persons were drinking in the courtyard of the house. Seeing the police all persons fled away leaving some plastic glasses but he could not flee away. We apprehended him and on searching the house we recover 1) 25 (twenty five) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600ml of country spirit) and (2) 24 (twenty four) bottle of country spirit designed as Dil Se, (each bottle contains 600 ml of country spirit) . On being interrogated the youth revealed his identity as Mohan Bhunia (40 Yrs) S/o-Lt Laxman Bhunia of Nodiha Bhuniapara , Ward no- 7, PS-Purulia (T) ,Dist- Purulia. On asked he could not produce any license in favour of selling, keeping or possessing liquor or country spirit. Accordingly I seized (1) 25 (twenty five) bottles of Country Spirit designed as 'Dil Khush' (each bottle contains 600ml of country spirit) (2) 24 (twenty four) bottles of country spirit designed as Dil Se(each bottle contains 600ml country spirit) (3) 08 (Eight) pcs empty 'Dil se' bottles (4) 05(four) plastic glasses from his possession after labeling and sealed properly and took sample of (S.L no-1&2) of the items and arrested him observing all the formalities regarding arrest as his offence comes under the ambit of 46A(c) of B.E. Act 1909.

Hence a specific case may kindly be started and arrange for its investigation.
