In producing herewith arrested accused namely Apurba Dey (52yr) & Lt. Akul Ch. Dey of Namopara, Rathnala, N.C. Dasgupta Road, Dist Parulia along with seized articles (i) 10 pieces of orange colour sweets made by curd (Ukhana) in a aluminium container (ii) one used open packet of colour in dust condition (approx 4 gm.) marked as Kamdhenu (for which written Melamil yellow for industrial use only) "Not for human consumption" in sealed and labeled condition (iii) 104 pieces of orange colour sweets out of sl. No.1 taken as sample in a sealed container in sealed and labeled condition, I Sri Tapas Kr. Ghosh, Insp. of Police, D.B. Parulia do hereby lodge a written complaint to the effect that today 12/10/18 on the basis of secret and credible source information I. Sri Tapas Kr. Ghosh, Insp. of Police, B.E.B, Parulia along with JC 571 Prasenjit Mandal, JC 427 Sourav Panja and HG 1427 Bernimadhab Chak had been to Parulia(T) PS and submit one reacation to OC Parulia(T) PS for rendering assistance and noted the credible information at Parulia(T) PS at 20:47hrs. vide Parulia(T) PS G.O. No. 679 dtd. 12/10/18. Thereafter I alongwith officer and forces of D.E.B Parulia and Parulia(T) PS left for Namopara, Rathnala, N.C Dasgupta Road under Parulia(T) PS to work out the information. On arrival to one sweet shop styled as "Nari Baba Mistura Bhendar" at Namopara, Rathnala, N.C Dasgupta Road, Parulia at 21:05hrs. I found in the workshop attached with the shop, the owner of the shop is engaged for mixing the colour with the curd (Ukhana) for preparing sweets (Jalapa) for colouring and attractive to the customers and also stored it in showcase of the shop for selling to the common people. On checking the packet which was using for artificial flavor with a view to cause serious injuries to human health and found noted on the packet "NOT FOR HUMAN CONSUMPTION". On being asked the owner failed to give any satisfactory account in respect of use for using such chemical (color) and confessed that he is using the chemical to attract the customer in large scale for his own profit without giving any care for hygine of public in general. Thus he committed offence punishable u/s 272/273/20B IPC. Accordingly, I seized the above articles from his possession under proper seizure list in presence of witnesses and arrested him after observing all rules with an information of grounds of arrest.

I therefore request you to start a case u/s 272/273/20B IPC against accused Apurba Dey (52yr) & Lt. Akul Ch. Dey of Namopara, Rathnala, N.C. Dasgupta Road, Dist Parulia.
