In producing herewith arrested accused namely Apartha Dey (52yrs) w/o Lt. Akul Ch. Dey of Namopara, Raibhala, N.C. Dasgupta Road, Dist Purulia along with seized articles (i) 30 pcs. of orange colour sweets made by curd (Ubbana) in a aluminium container (ii) one mud open packet of colour in dust condition (approx 4 gms.) marked as Kamdhenu (on which written Metallid yellow for industrial use only) "Not for human consumption" in sealed and labeled condition (iii) 04 pcs of orange colour sweets out of sl. No.1 taken as sample in a plastic container in sealed and labeled condition, I Sri Tapas Kr. Ghosh, Insp. of Police, DEB, Purulia do hereby lodge a written complaint to the effect that today 12.10.18 on the basis of secret and credible source information I, Sri Tapas Kr. Ghosh, Insp. of Police, DEB, Purulia along with JC/571 Prasenjit Mishra, JC/427 Sourav Panja and HC/1427 Beunadhab Chakrabarti to Purulia(T) PS and submit one requisition to OC, Purulia(T) PS for rendering assistance and noted the credible information at Purulia(T) PS at 20:47hrs. vide Purulia(T) PS G.O. No. 679 dt. 12.10.18. Thereafter I alongwith officer and forces of DEB Purulia and Purulia(T) PS left for Namopara, Raibhala, N.C. Dasgupta Road under Purulia(T) PS to work out the information. On arrival at one sweet shop styled as "Nani Bani Mistanna Bhandar" at Namopara, Raibhala, N.C. Dasgupta Road, Purulia at 21:05hrs. I found in the workshop attached with the shop, the owner of the shop is engaged for mixing the colour with the curd (Ubbana) for preparing sweets (orange) for colouring and attractive to the customers and also stored as in showcase of the shop for selling to the common people. On checking the packet which was using for artificial flavor with a view to cause serious injuries to human health and found noted on the packet "NOT FOR HUMAN CONSUMPTION". On being asked the owner failed to give any satisfactory account in respect of use for using such chemical (colorant) and confessed that he is using the chemical to attract the customer in large scale for his own profit without giving any care for hygiene of public in general. Thus he committed offence punishable u/s 272/273/120B IPC. Accordingly, I seized the above articles from his possession under proper seizure list in presence of witnesses and arrested him after observing all rules with an information of grounds of arrest.

I therefore request you to start a case u/s 272/273/120B IPC against accused Apartha Dey (52yrs) w/o Lt. Akul Ch. Dey of Namopara, Raibhala, N.C. Dasgupta Road, Dist Purulia.
