The humble petition of the complainant

Most respectfully sheweth :-

1. That the complainant is a married person and he got married with one Manju Sutrachar, D/o Sri Biswanath Sutrachar of Village/P.O./P.S. Silli, District-Ranchi (Jharkhand) 10 (Ten) years back according to Hindu rites, customs and usages and out of such wed-lock they got blessed with a daughter namely, Swasty Dutta and Anjan aged about 9 years and 7 years respectively and that the marital tie thereof is still subsisting.

2. That on 20/02/2018 in the morning hours the complainant's wife Manju Sutradhar and his 2 children aforesaid found raising from the house in absence of the complainant and others and as such the complainant and his parents and other family members searched at different places but could not find. Subsequently on 23/02/2018 the complainant's parents came to learn that the accused Manoj Dutta confined the complainant's wife and the 2 children by applying force and said accused Manoj Dutta has been living with the complainant's wife as husband and wife illegally at his house at Village Arrah under Adra P.S. and in this respect accused Nos. 2 and 3 being the parents of accused NO. 1 are instrumental and co-operating to such ~~heinous~~ heinous offence. Having been learnt the complainant's parents went ^{to} the house of accused Nilmadhab Dutta with an object to bring the complainant's wife and the 2 children back to Raghunathpur but to no result as the accused persons Nilmadhab Dutta and his wife Sankari Dutta threatened and drove them out of the house.

3. That thereafter on 24/02/2018 the complainant's father reported the matter to Raghunathpur P.S. and that being aware of such matter aforesaid accused No. 1 took the complainant's wife and 2 children to unknown place within Adra town at the instance of accused Nos. 2 and 3.

4. That subsequently the complainant accompanied by his father in law namely, witness No. 5 Biswanath Sutradhar of Silli aforesaid had been to the house of accused Nos. 2 and 3 to find the complainant's wife and 2 children but to no result rather they were assaulted by the said accused persons. Subsequently the complainant and others came to learn that the accused No. 1 Manoj Dutta, with the active aid and abetments of his parents who figure as accused Nos. 2 and 3 has kept/confined the complainant's wife and the 2 children in a rented house within Nra Township.

5. That on 31/07/2018 last the complainant came to learn reliably that accused Manoj Dutta had confined complainant's wife and 2 children illegally in a house at Palashkola-Adra and on being aware the complainant along with his father in law namely, Biswanath Sutradhar (Father of Manju Sutradhar) and brother in law namely, Dinesh Sutradhar (elder brother of said Manju Sutradhar) went to Palashkola and met the accused No. 1 and found that the accused Manoj Dutta had been living with Manju Sutradhar illegally as husband and wife to which the complainant and his father in law and brother in law aforesaid protested severe illegal activities of accused No. 1 whereupon accused Manoj Dutta with the

help of associates threatened the complainant and others with dire consequences and thereafter he wrested all of them out of the house. Accused Manoj Dutta with the help of ~~the~~ his parents has been illegally living with the complainant's wife and 2 children after kidnapping and enticing them and said Manoj Dutta has practically confined complainant's wife and has been living with her as husband and wife causing the entire society polluted in broad day light.

6. That the complainant thereafter, i.e., on 01/08/18 lodged one written F.I.R. against the aforesaid 3 accd. persons before Raghunathpur P.S. to which the Duty officer assured to take necessary action in that respect but to no result although days and weeks elapsed thereafter and as such the complainant sent one appeal before the S.P. Purulia on 24/08/2018 but it is unfortunate that a month elapsed but nothing tangible has been effected so far in this respect. Hence the complainant after complying the provision of the section 154 Cr.P.C. has ~~now~~ come before this Ld. court and files the complaint petition for relief.
