The humble petition of the complainant

Most respectfully sheweth :-

1. That the marriage between the complainant and  
Accd.No.1 namely, sk. Kalu was solemnised according  
to Muslim rites, customs and usages prevalent in their  
community on 01/05/2016 at the paternal residence of  
the complainant at village-Kalagars aforesaid and it  
is pertinent to mention that at the time of such  
marriage complainant's father gave cash of Rs.55,000/-  
and 50 Nos. of necessary costly household articles  
to the accused No.1 towards bridal gift as per the  
demand of all the accused persons. It is significant  
to state that Accd. Nos. 5 and 6 took active role in  
respect of entire proceedings of said marriage.

2. That the complainant after such marriage went with accd. No.1 to her matrimonial home at Village Jemari aforesaid and started living with her husband (accused No.1) and other in-laws namely, accused Nos.2 to 4 in joint mess.

3. That the complainant was more or less well for a year but at the time of Durgapuja in 2017 i.e., on 15/09/2017 in the morning accused No.1 at the instance of the accused Nos. 2 to 4 told the complainant to bring Rs. 50,000/- from her father to which the complainant refused and protested whereupon accused Nos. 1 to 4 started torturing the complainant both mentally and physically on various ways such as they quarrelled and assaulted the complainant on the grounds of flimsy domestic losses off and on. The complainant considering her greater interest of conjugal life brooked all such tortures without any murmur but it is irony of fate that the character and nature of accused No.1 was not changed as he went on demanding and torturing at times at the instance of accused Nos.2 to 4. It is pertinent to mention that the accd.Nos. 5 and 6 although permanent residents of Village-Kalagara aforesaid but they were/are residing at Jemari aforesaid and that they have well intimacy with accd. Nos.1 to 4 and that they (accd. Nos. 5 and 6) are also instrumental to said offences.

4. That on 6/5/2019 at about 11 A.M. accused No.1 at the instance of accused Nos. 2 to 4 in a preplanned way again told the complainant to bring Rs. 50,000/- from her father to which the complainant being disgusted and frustrated protested whereupon all the ~~4~~ <sup>5</sup> accd. persons namely, accused Nos. 1 to 4 in a joint concert assaulted the complainant brutally and thereafter they drove the complainant out of the matrimonial home keeping all her stridhans and it is pertinent to mention that at that time the accused No.1 openly told that if Rs. 50,000/- was not given he would remarry.

The complainant thereafter with severe bodily pain and mental agony reached her paternal house ~~anyhow~~ at the Village-Kalagra, with extreme hardship and reported the entire incident to the witnesses who on hearing so advised the complainant not to lodge complainant anywhere for greater interest of conjugal life.

5. That on 07/07/2018 at about 9.00 A.M. accused Nos. 1 to 4 namely (1) sk. Kalu (2) Anera Bibi (3) sk. Fajar Ali and (4) Ruksana Bibi came to the house of the accused Nos. 5 and 6 namely, Sarif Kazi and Marufa Bibi both of Village-Kalagra aforesaid and conspired with the accused Nos. 5 and 6 and thereafter all the aforesaid 6 accused persons went to the paternal house of the complainant by a Bolero car and all the accused persons asked the complainant as to whether she had arranged Rs. 50,000/- to which the complainant on

hearing so protested vehemently whereupon all the aforesaid 6 accd. persons in a joint concert assaulted the complainant brutally at random to which the complainant being helpless cried for help and hearing her cry witness Nos. 4 and 5 rushed to the place of occurrence and saw the entire incident and they practically saved the complainant from the deadly clutches of the aforesaid 6 accd. persons. The accd. persons thereafter seeing the public and neighbours left the place with the help of Bolero car on hot haste. The complainant sustained injuries on different parts of her body and head due to such assaults and became ill and thereafter the complainant got herself treated at Raghunathpur P.H.C. at the help of witnesses on the very date of incident and thereafter the complainant lodged a written F.I.R. enclosing the veridical copy of Medical paper on the same date, i.e., on 7/7/2018 before Raghunathpur P.S. against all 6 accd. persons to which the duty officer, <sup>assured</sup> ~~assured~~ to take necessary action against the accd. persons but to no result. Hence the complainant sent a special in this respect to the S.P., parulda under speed post on 2/8/2018 enclosing the copies of written F.I.R. dated 7/7/2018 and medical papers dated 7/7/2018 but it is unfortunate that nothing tangible had been effected so far although one month elapsed. Hence the complainant being helpless has been obliged to file this complaint after observing the provisions of 154 Cr.P.C.

It is therefore prayed that the O/C, Raghunathpur P.S. may kindly be directed to investigate the case u/s 156(3) Cr.P.C., treating this complaint as F.I.R.
