I, SI Rajat Choudhary, O/C Raghunathpur PS brought under arrest the accused persons namely (1) Ajmat Khan (25 Yrs.) (Driver of Vehicle No. JH 10BA/4716) S/o Lt Habib Khan of Pirkuban, PS - Jharia, Dist.- Dhanbad (Jharkhand), (2) Md. Guddu (28 Yrs.) (Khalasi of the said vehicle) S/o Lt. Jal Mahammad of Fushbangla, PS - Jorapukur, Dist.- Dhanbad (Jharkhand) and seized vehicle No. JH 10BA/4716 loaded with 05 (Five) Cows and lodged a FIR against the above noted arrested accused persons, (3) owner of the vehicle No. JH 10BA/4716 and (4) the transporter of the above noted seized Cows to the effect that today (21.10.18) during special raid duty at around 00:15 hrs myself alongwith forces at Raghunathpur – Bankura Road near Chinpina Rly. Gate, found one Pick UP Van was running from Raghunathpur side and was headed to Bankura side with excessive speed and accordingly we intercepted the vehicle and found one person was on the driver's seat and another was beside him and there was none except them. In their presence I found that the vehicle bearing Reg. No. JH 10BA/4716 was loaded with total 05 (Five) cows of different size. On asked they revealed their identity as noted above but their identities could not be verified as they could not produce any identity prove document. On demand they could not produce any papers in respect of the vehicle as well as the 05 (Five) Cows and about the procurement of the cattles as well as the vehicle they stated incoherently and from their statements there is every ground to believe that they have procured the vehicle and the cattles in any fradulent means or by means of theft and was trying to conceal them and they are habituated offender in such offense. Moreover they were carrying those cattles in the vehicle in such a manner that they were huddling together for the want of space. The above noted accused persons treated the cattles in such a manner so as subject those to unnecessary pain as they loaded those in such a vehicle which does not measure sufficiently either in height, length or breadth. Hence I seized those 05 (Five) Cows and the vehicle bearing Reg. No. JH 10BA/4716 from 00:35 hrs to 01:45 hrs from the possessions of the above noted accused persons under proper seizure list where the description of each cow is mentioned and after seizure I arrested them after maintaining all formalities regarding their arrest. It is to be noted that there is no public witnesses available at the odd hours of night hence my accompanying police forces stood witnesses. After that I brought the arrested accused persons, seized vehicle and the seized cows to PS.

Hence I do record Raghunathpur PS Case No 169/18 dt 21.10.18 U/S 379/411/413/414 IPC and U/S 11(a)(d)(e) of the Prevention of Cruelty to Animals Act, 1960 against (1) Ajmat Khan (25 Yrs.) (Driver of Vehicle No. JH 10BA/4716) S/o Lt Habib Khan of Pirkuban, PS – Jharia, Dist.- Dhanbad (Jharkhand), (2) Md. Guddu (28 Yrs.) (Khalasi of the said vehicle) S/o Lt. Jal Mahammad of Fushbangla, PS – Jorapukur, Dist.- Dhanbad (Jharkhand), (3) owner of the vehicle No. JH 10BA/4716 and (4) the transporter of the above noted seized Cows as suo-moto and directed SI Gopal Bhattacharjee to investigate the case.
