
Sir, Enclosed pl find a copy of application received from Debasish Biswas S/O Lt. G.C Biswas Sr. Mnager (PS). CHP (O) STPS,WBPDCL Santaldih on 06.10.2018 vide Memo no STPS/CHP/ 2506 dated 06.10.18. to the effect that on 05.10.18 Security personnel reported at around 20.00 hrs (yesterday) that some parts of Loco Engine found dismantled . AS observed that Cables (300 swg) jointing to Tractions motors and Rectifier leads found missing along with some other parts which was not traced fully and will be inform to you accordingly in due course. Please note that the loco Engines are not operative from July 2016 and 24 hrs security surveillance was arranged through memo from the dept. Some unknown miscreants committed theft in respect of "Cables, Leads and others parts " from the Locomotive Engines. The said Engines have been placed at track Hopper at CHP. STPS WBPDCL.

Under these circumstances you are requested to lodge an FIR and take necessary action from your end at the earliest.
